SUBJECT : APPLICATION OF MONITORING FEE TO NEW GAMING SITES

Please be advised that the PAGCOR Board of Directors approved in its meeting on January 4, 2017 the implementation and inclusion of amendments to Regulations 4 and 5 of the following regulatory manuals regarding the application of Monitoring Fee to new gaming sites:

1. Gaming Site Regulatory Manual version 2.2 (Electronic Games); and
2. Gaming Site Regulatory Manual version 2.2 (Bingo Games).

Payment by the Operator of Monitoring Fee amounting to thirty five thousand pesos (PhP35,000.00) shall also apply to new gaming sites. The following amendments can now be viewed or downloaded from the corresponding "Amendment" link at "Electronic Gaming & Poker" page through "Regulatory" page of the PAGCOR website:

1. Regulation 4 (Fees and Other Monetary Requirements), Section 1-(d). The description/definition of the Monitoring Fee shall be revised.

(d) Monitoring Fee – shall be paid whenever an Operator applies for renewal of license.	(d) Monitoring Fee – shall be paid upon approval of the application by the PAGCOR Board of Directors or whenever an Operator applies for renewal of license.


2. Regulation 4 (Fees and Other Monetary Requirements), Section 2. Cell in Table of Fees, i.e. "Monitoring" row and under the column "New Site," shall be checked.

3. Regulation 5 (The Application), Section 5-(b). A subsection for payment of Monitoring Fee shall be inserted as subsection (c).

(c) Payment of the applicable Fees is NOT an assurance of approval of the gaming site.	(c) Payment of Monitoring Fee shall be made upon approval of the application by the PAGCOR Board of Directors and prior to commencement of operations of the gaming site. (d) Payment of the applicable Fees is NOT an assurance of approval of the gaming site.

Effectivity of the above amendments shall be on January 5, 2017.
