To intensify implementation of developed Responsible Gaming programs, specifically on the prohibition of excluded persons to enter and play in all gaming establishments regulated by PAGCOR, we enjoin all gaming site operators (Bingo/Electronic games and Poker) to comply on the following:

1. Apply for access to the National Database of Restricted Persons (NDRP) by accomplishing the attached RG Form 5. Please submit accomplished form thru Vladimir.Gonzales@pagcor.ph (deadline for submission is not later than June 16, 2017);
2. Implementation of Player Registration database in all gaming sites by July 1, 2017 (tagging of excluded/banned person's names should already be effected in the player database from the NDRP);
3. Installation of RG collaterals (posters) in access points and toilets;
