**WHEREAS**, the Requisition Voucher (RV), Terms of Reference (TOR) and other pertinent documents were received by the branch Procurement Section on August 19, 2020;

**WHEREAS**, in the Pre-Procurement Conference last September 08, 2020, BBAC, CF-Bacolod evaluated all the documents presented, including the technical specifications / TOR integrated in the Bidding Document, wherein necessary modifications were discussed. The BBAC members agreed that the ABC of the project shall be Six Hundred Ninety-Eight Thousand Seven Hundred Forty-Five Pesos (PhP 698,745.00) has a difference of Two Million Five Hundred Eleven Thousand Seven Hundred Seven Pesos & 61/100 (PhP 2,511,707.61) to the approved budget in the approved APP;

**WHEREAS**, the Invitation to Bid (ITB) was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR-CF-Bacolod from September 18, 2020 to October 7, 2020, and also hand-carried and sent through fax to prospective bidders;

**WHEREAS**, the BBAC agree not to conduct Pre-Bid Conference since the projects is below one million pesos;




