WHEREAS, the Bids and Awards Committee (BAC) 2 has been tasked to handle the procurement of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the Procurement Processing Request (PPR) and other pertinent documents were received by the Procurement Department (PD), acting as the BAC Secretariat, on October 8, 2020;

WHEREAS, in the Pre-Procurement Conference held last October 29, 2020, the BAC 2 reviewed and evaluated all the documents presented, including the technical specifications integrated in the Request for Quotation (RFQ);

WHEREAS, the RFQ was posted at the websites of PAGCOR and the Philippine Government and Electronic Procurement Systems (PhilGEPS), and in a conspicuous place within the premises of PAGCOR Corporate Annex Office from November 11, 2020 to November 17, 2020, and was also sent through electronic email to prospective bidders from the PAGCOR's Registry of Suppliers;

WHEREAS, on the deadline for the Submission and Receipt of Quotations held on November 17, 2020, no bid was received;

WHEREAS, in the Deliberation meeting held on November 23, 2020, the BAC 2 resolved to declare a Failure of Negotiated Procurement (Small Value) pursuant to Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, since no bid was received;

WHEREAS, in the same meeting, the end-user, ITD, recommended to the BAC 2, the cancellation of the project since the requirement is no longer necessary;

NOW, THEREFORE, WE, the Members of the Bids and Awards Committee (BAC) 2, hereby **RESOLVE**, as it is hereby **RESOLVED**, to declare a Failure of Negotiated Procurement (Small Value) of the **Video Conferencing Tool Hosted in a Cloud under ITB No. SV20-10-029COR** pursuant to Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act (R.A.) 9184, since no bid was received.
