### **RESOLUTION DECLARING FAILURE OF PUBLIC BIDDING AND THE CONDUCT OF REBIDDING**

**WHEREAS**, the Bids and Awards Committee (BAC) 1 has been tasked to handle the procurement of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

**WHEREAS**, the Procurement Processing Request, approved Annual Procurement Plan (APP) for CY 2020, quotations and other pertinent documents were received on March 3, 2020, by the Procurement Department (PD), acting as the BAC Secretariat;

**WHEREAS**, due to the declaration of Community Quarantine, the procurement of the project was postponed until June 2020;

**WHEREAS**, in the Pre-Procurement Conference held last June 25, 2020, the BAC 1 together with the representatives of the end-user, FMED, reviewed and evaluated all the documents presented, including the Terms of Reference (TOR) integrated in the Bidding Documents;

**WHEREAS**, in the same meeting, the BAC 1 agreed to proceed with the finalization of the bidding documents and posting of the requirement upon end-user's submission of the revised TOR:

**WHEREAS**, during the Second (2<sup>nd</sup>) Pre-procurement Conference held on August 5, 2020, the end-user explained that there is no need to revise the TOR since a part of the Scope of Works in the Technical Specifications stated that, "The supplier shall conduct actual inspection at the sites to determine the proper equipment to be used." Thus, said requirement is sufficient to address the kind of truck to be used;

**WHEREAS**, in the same meeting, the BAC 1 resolved to proceed with the finalization and posting of the Bidding Documents using the same TOR provided by the end-user but the end-user must ensure that during the contract implementation it will not cause any problem and it will not incur any additional cost to PAGCOR;

**WHEREAS**, the bidding documents was finalized;

**WHEREAS**, the Invitation to Bid (ITB) was posted from September 7 to 28, 2020 at the websites of PAGCOR and the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR Corporate Annex Office, and also sent through email to prospective bidders listed in the PAGCOR's Registry of Suppliers;

**WHEREAS**, copies of the ITB were also sent through email and fax to prospective bidders;

**WHEREAS**, A Bid Bulletin was issued to reschedule the Pre-bid Conference from September 15 to September 16, 2020 due to lack of quorum;

**WHEREAS**, the said bid bulletin was posted from September 7 to 28, 2020 at the websites of PAGCOR and the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR Corporate Annex Office;

**WHEREAS**, in the Pre-Bid Conference held on September 16, 2020, the BAC 1 discussed the salient procedures for the conduct of public bidding and the contents of the Bidding Documents to the lone participating bidder who attended the conference, Sta. Fe Relocation;

**WHEREAS**, only Sta. Fe Relocation bought the cost for the sale of the Bidding Documents;

**WHEREAS**, on September 28, 2020, during the deadline for the Submission and Receipt of Bids, no bidder submitted its bid;

**WHEREAS**, in the same meeting, the BAC 1 declared a Failure of Bidding since no bid was received;

**WHEREAS**, the end-user signified that they intend to re-conduct the procurement process, using the same budget and TOR;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee (BAC) 1, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare a Failure of Bidding for Procurement of Services for the Hauling and Relocation of Container Vans at PAGCOR Imus Complex under ITB No. PB20-08-043COR, pursuant to Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, since no bid was received, and
- b) To conduct a rebidding for Procurement of Services for the Hauling and Relocation of Container Vans at PAGCOR Imus Complex with re-posting, pursuant to Section 21.2 of the 2016 Revised IRR of RA 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates, pursuant to Section 35.2 of the same IRR of RA 9184.
