### RESOLUTION DECLARING FAILURE OF BIDDING AND THE CONDUCT OF RE-BIDDING FOR LOTS 1, 3 AND 4

**WHEREAS**, the Bids and Awards Committee (BAC) 3 has been tasked to handle the procurement of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

**WHEREAS**, the Procurement Processing Request, approved Annual Procurement Plan (APP) for CY 2020, basis of costing and other pertinent documents were received on August 24, 2020 by the Procurement Department (PD), acting as the BAC Secretariat;



**WHEREAS**, in the Pre-Procurement Conference held last August 27, 2020, the BAC 3 together with the representatives of the end-user, CF-Winford, reviewed and evaluated all the documents presented, including the technical specifications integrated in the Bidding Documents and agreed that the Approved Budget for the Contract (ABC) to be posted is in the total amount of Ninety-Nine Million Five Hundred Three Thousand Seven Hundred Pesos (PhP99,503,700.00), VAT Exclusive, Zero-Rated Transaction;

**WHEREAS**, in the same meeting, the BAC 3 resolved to proceed with the finalization and posting of the Invitation to Bid (ITB) and Bidding Documents for the project;

**WHEREAS**, the ITB was posted from September 15, 2020 to October 5, 2020 at the websites of PAGCOR and the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR Corporate Annex Office;

**WHEREAS**, copies of the ITB were also sent through electronic mail to prospective bidders listed in the PAGCOR's Registry of Suppliers;

**WHEREAS**, during the Pre-Bid Conference held on September 23, 2020, five (5) bidders attended the forum, namely:

1. EDCT Food Services;
2. I-Foods Group, Inc.;
3. Treeside;
4. MGO; and
5. Syjuco Catering Services.

**WHEREAS**, Bid Bulletin No. 1 was issued on September 28, 2020 to reflect some of the modifications in the bidding documents and the Technical Specifications of the project and moved the deadline for the Submission and Receipt of Bids from October 5, 2020 to October 12, 2020;

**WHEREAS**, Bid Bulletin No. 2 was also issued on October 6, 2020 to reflect additional changes in the Technical Specifications of the project based on the discussions during the Consultation Meeting held last October 5, 2020, and moved the deadline for the Submission and Receipt of Bids from October 12, 2020 to October 19, 2020;

**WHEREAS**, three (3) prospective bidders bought the Bidding Documents of the said project and submitted their bids on October 19, 2020, the deadline for the Submission and Receipt of Bids, namely:

1. EDCT Food Services (Lots 2 and 5);
2. I-Foods Group, Inc. (Lots 1 and 3); and
3. Syjuco Catering Services (Lot 5).

**WHEREAS**, on October 19, 2020, upon conclusion of the Opening and Preliminary Examination of the First (1<sup>st</sup>) Bid Envelopes (Eligibility Documents and Technical Component), the results were as follows:

**WHEREAS**, on the same day, the BAC 3 informed the authorized representatives of I-Foods Group, Inc. and Syjuco Catering Services of the above-cited reasons for their disqualification;

**WHEREAS**, the PD received letters from I-Foods Group, Inc. and Syjuco Catering Services on October 19 and 20, 2020, respectively, requesting for reconsideration on their disqualification during the Opening and Preliminary Evaluation of Bids held last October 19, 2020;

**WHEREAS**, in a meeting held on October 22, 2020, the BAC 3 denied the requests of the aforementioned bidders and issued a Resolution on the Request for Reconsideration on October 30, 2020;

**WHEREAS**, Syjuco Catering Services and I-Foods Group, Inc. acknowledged receipt of the letters on November 5, 2020 and November 9, 2020, respectively, and signed the waiver to file a protest;



**WHEREAS**, in a meeting held on November 16, 2020, the BAC 3 declared a failure of bidding for Lots 1, 3 and 4 of the project;

**WHEREAS**, the end-user was instructed to conduct a mandatory review of the requirements to determine the reason behind the failure of bidding and to revise the specifications and cost estimates, if necessary, if they intend to rebid the project;

**WHEREAS**, in the same meeting, the end-user signified its intent for the re-conduct of its procurement under the same terms, conditions and using the same budget for the project;

**WHEREAS**, the BAC 3 emphasized that for the rebidding of the project, it must be included in the Approved 2021 Annual Procurement Plan and the procurement shall be handled by the Branch Bids and Awards Committee of CF-Winford.


**NOW, THEREFORE, We**, the Members of the Bids and Awards Committee (BAC) 3 hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare a Failure of Bidding for Lots 1, 3 and 4 of the Supply and Delivery of Five (5) Lots Food and Beverages for CF-Winford and its Satellites for a Period of Three (3) Years under ITB No. PB20-09-049COR pursuant to the following Sections of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184:

1	Supply and Delivery of Food and Beverages for Employees for a Period of Three (3) Years for Winford Satellite	Failure of Bidding pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, since the prospective bidder was declared ineligible.
3	Supply and Delivery of Food and Beverages for Employees for a Period of Three (3) Years for Grandz Satellite	Failure of Bidding pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, since the prospective bidder was declared ineligible.

2. To conduct the rebidding for Lots 1, 3 and 4 of the Supply and Delivery of Five (5) Lots Food and Beverages for CF-Winford and its Satellites for a Period of Three (3) Years with reposting pursuant to Section 21.2 of the same IRR; and
3. To endorse to the Branch Bids and Awards Committee (BBAC) of CF-Winford the rebidding for the remaining lots of the said project.
