BBAC RESOLUTION DECLARING THE SINGLE CALCULATED & RESPONSIVE QUOTATION (SCRQ) AND RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT TO JID ELECTRICAL SERVICES

WHEREAS, the Facilities Management and Engineering Section (FMES) has a requirement for the Preventive Maintenance Service of the existing Power Transformer 3-300kVA and 3-100kVA under SV20-09-012BAC with an approved budget for the Contract amounting to: One Million Pesos (PhP1,000,000.00 Vat Exclusive, Zero Rated Transaction, as approved by the Board of Directors last May 18, 2020;

WHEREAS, the use of Negotiated Procurement (Small Value) was approved by the Board of Directors on May 18, 2020 upon recommendation by the Branch Bids and Awards Committee CF-Bacolod in accordance with Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184 since the amount involved for said project is within the threshold of One Million Pesos (PhP1,000,000.00) as provided under Annex "H" of the same IRR of R.A. 9184;

WHEREAS, the Request for Quotation (RFQ) for the aforesaid requirement was posted in the Philippine Government Electronics Procurement System (PhilGeps) and in a conspicuous place within the vicinity of Casino Filipino – Bacolod from September 23-30, 2020. Copies of the Request for Quotations (RFQ) were also sent to prospective bidders through electronic mail and fax such as **JID ELECTRICAL SERVICES, NEWBRIDGE ELECTRICAL ENTERPRISES and NRA ELECTRICAL SERVICES.**

WHEREAS, After Eight (8) calendar days posting, only one (1) bidder submitted a sealed quotation **JID ELECTRICAL SERVICES**

WHEREAS, After the Opening and Preliminary Examination of Envelopes (Eligibility, Technical and Financial Component), **JID ELECTRICAL SERVICES** the Single bidder got a "passed rating"; as follows;

WHEREAS, the lone bidder complied with the bidding requirements as prescribed in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184. After completing the tabulation, hereunder the financial quotations of the qualified bidder, as read:

WHEREAS, after consideration of the facts presented, BBAC, CF-Bacolod and End-User determined **JID ELECTRICAL SERVICES** as the bidder having the Single Calculated and Responsive Quotation for Preventive Maintenance Service of the Existing Power Transformer 3-300kVA and 3-100kVA.






