Please be advised that the CF-Davao Branch Bids and Awards Committee (BBAC) resolved to declare the retroactive suspension of the following procurement projects effective March 17, 2020 due to the COVID-19 pandemic, subsequent declaration of the State of Calamity and the implementation of community quarantine throughout the National Capital Region pursuant to GPPB Resolution No. 09 – 2020 entitled "Approving Measures for the Efficient Conduct of Procurement Activities During a State of Calamity, or Implementation of Community Quarantine or Similar Restrictions."
