BBAC CF-DAVAO RESOLUTION RECOMMENDING APPROVAL FOR THE FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF ONE (1) YEAR FOOD AND BEVERAGES (F&B) FOR CASINO CUSTOMERS, GUESTS AND OFFICERS OF TAGUM SATELLITE UNDER ITB NO. PB21-07-002DAV

WHEREAS, the Branch Bids and Awards Committee (BBAC) CF-Davao has been tasked to handle the procurement of requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the Procurement Processing Request (PPR), Annual Procurement Plan (APP) for CY 2021, Technical Specifications and other pertinent documents were received by the Procurement Section (PS), acting as the BBAC Secretariat on July 15, 2021;

WHEREAS, in a Pre-Procurement Conference held last July 20, 2021, the BBAC CF-Davao together with the representative of the end-user, Customer Relations Section (CRS), reviewed and evaluated all the documents presented, including the technical specifications integrated in the Bidding Documents;

WHEREAS, the committee resolved to revise the Final Annual Procurement Plan (APP) 2021 to include the Officers meals in the budget and title of the project;

WHEREAS, on July 27, 2021, the Acting Branch Manager, as duly delegated by the Board of Directors, approved the revision;

WHEREAS, the Invitation to Bid (ITB) was posted at the websites of PAGCOR and the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR Annex from July 29, 2021 to August 18, 2021;

WHEREAS, copies of the ITB were also sent to prospective bidders thru electronic mail copy furnished the representatives from the end-user, CRS.

WHEREAS, after the Opening and Preliminary Examination of Bids held on August 18, 2021, the BBAC declared a "Failure of Bidding" for Lot 5 in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184, which states:

"Section 35. Failure of Bidding"

35.1. The BAC shall declare the bidding a failure when:


a) No bids are received; and

Declaration of a "Failure of Bidding" for the Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. PB21-07-002DAV, pursuant to Section 35.1 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184; and
2. Conduct of re-bidding Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite with re-advertisement and/or re-posting, pursuant to Section 35.3 of the IRR of RA 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates.
