Please be advised that the Branch Bids and Awards Committee (BBAC), CF-Tagaytay resolved to declare the retroactive suspension of the following procurement projects effective August 6, 2021, due to the declaration and the implementation of community quarantine throughout the National Capital Region and nearby provinces including Cavite province pursuant to GPBB Resolution No. 99-02020 entitled "Approving Measures for the Efficient Conduct of Procurement Activities During a State of Calamity, or Implementation of Community Quarantine of Similar Restrictions".

Consequently, the BBAC, CF-Tagaytay would also like to notify all concerned bidders on the estimated resumption of the procurement activities for the following projects upon the lifting of Community Quarantine:

### **Public Bidding Projects**

- Tolling the Period of the Bidding/Procurement Activity starting from the above-mentioned date of suspension.
