SUBJECT: NOTICE TO PROCEED

We are pleased to inform you that the Purchase Contract for the Supply of Gasoline and Diesel through Fleet Card Technology System for Two (2) Years under ITB No. PB20-01-015CORa-06, which was awarded to you, has been signed by the contracting parties.

Thus, we are issuing this Notice to Proceed for you to complete the delivery of the new cards within thirty (30) calendar days from the date of receipt of this notice. The supply and purchase of gasoline and diesel shall commence upon receipt of the ready-to-use fleet cards. All cards shall be delivered at Transportation Services Department (TSD), Enterprise Services Group, PAGCOR Main Corporate Office, 9th Floor, IMET BPO Tower, CBP-1A, Metropolitan Park, Roxas Boulevard, Pasay City.

Further, please be reminded of the following:

1. For the Warranty Security, should you opt for a Special Bank Guarantee, it must be submitted on or before the scheduled delivery. Otherwise, PAGCOR shall apply the standard retention money of at least one percent (1%) of the contract price. The same shall be released after three (3) months from the formal acceptance, if and when there is no patent and latent defects.
2. For the Performance Security, please submit the renewal of the Irrevocable Standby Letter of Credit prior to its expiration on October 9, 2021 or any of the prescribed forms of Performance Security, which is valid until the duration of the Purchase Contract.




