RESOLUTION DECLARING FAILURE OF REBIDDING AND RECOMMENDING FOR APPROVAL BY THE CHAIRMAN AND CHIEF EXECUTIVE OFFICER ON THE RESORT TO NEGOTIATED PROCUREMENT (TWO FAILED BIDDINGS) AND REVISION/ UPDATING OF THE ANNUAL PROCUREMENT PLAN (APP) FOR CY 2021

WHEREAS, the Bids and Awards Committee (BAC) 1 has been tasked to handle the procurement of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the Procurement Processing Request, approved Annual Procurement Plan (APP) for CY 2020, quotations and other pertinent documents were received on January 7, 2020, by the Procurement Department (PD), acting as the BAC Secretariat;

WHEREAS, during the first conduct of public bidding of the above requirement, the BAC 1 declared on March 2, 2020 a Failure of Bidding for the Lot 1 (Supply and Delivery of Beer in Can) of the Supply and Delivery of Four (4) Lots of Beer, Soft Drinks, Fruit Juices and Bottled Water for SOGs and Various Departments under ITB No. PB20-01-020COR since no bid was received, pursuant to Section 35.1 (a) of the 2016 Revised Implementing Rules and Regulation (IRR) of Republic Act (R.A.) 9184;

WHEREAS, the procurement for said lot/requirement was reprised through competitive bidding under ITB No. PB20-01-020CORa-09;

WHEREAS, in the First (1st) Pre-Procurement Conference held on March 11, 2020 for the rebidding of the project, the BAC 1 resolved to proceed with the finalization of the bidding documents using the amount of Three Million Nine Hundred Eleven Thousand One Hundred Forty-Two Pesos and 72/100 (PhP3,911,142.72), VAT Exclusive, Zero-Rated Transaction, as the ABC to be posted;

WHEREAS, during the Second (2nd) Pre-procurement Conference held on July 20, 2020, the BAC 1 instructed the end-user to decide if they still intend to proceed with its procurement;

WHEREAS, during the Third (3rd) Pre-procurement Conference held on September 14, 2020, the BAC 1 noted the decision of the end-user to continue the project;

WHEREAS, the BAC 1 also noted the following information based on the Revised Terms of Reference (TOR) submitted by the end-user dated September 1, 2020:

1. The requirement of Beer for Marketing Department was already cancelled;
2. The ABC of Three Million Nine Hundred Eleven Thousand One Hundred Forty-Two Pesos and 72/100 (PhP3,911,142.72), VAT Exclusive, Zero-Rated Transaction, which was obtained from a twenty percent (20%) increase from the previous posted budget in the amount of Three Million Two Hundred Fifty-Nine Thousand Two Hundred Seventy-Eight Pesos and 96/100 (PhP3,259,278.96), was reduced to Three Million Eight Hundred Twenty-One Thousand Eight Hundred Seventy-Three Pesos and 92/100 (PhP3,821,873.92), VAT Exclusive, Zero-Rated Transaction due to the exclusion of the requirement for Marketing Department.

WHEREAS, in the same meeting, the BAC 1 resolved to proceed with the rebidding of the project using the amount of Three Million Eight Hundred Twenty-One Thousand Eight Hundred Seventy-Three Pesos and 92/100 (PhP3,821,873.92), VAT Exclusive, Zero-Rated Transaction, as the ABC to be posted;

WHEREAS, the Invitation to Bid was posted from October 9 to November 4, 2020 at the websites of the Philippine Government Electronic Procurement System (PhilGEPS) and PAGCOR, as well as, in a conspicuous place with the premises of PAGCOR Corporate Annex Office;

WHEREAS, copies of the ITB were also sent through email and fax to prospective bidders;

WHEREAS, in a Pre-bid Conference held on October 19, 2020, the BAC 1, thru the BAC Secretariat, discussed the salient procedures of the Bidding Process to the two (2) prospective bidders who attended the forum, namely:

1. MK Lanoch, and
2. TPV Trading

WHEREAS, on November 4, 2020, the deadline for the Submission and Receipt of Bids, no bid was received;

WHEREAS, the BAC 1 declared a Failure of Rebidding pursuant to Section 35.1(a) of the 2016 Revised IRR of RA 9184, since no bid was received;

WHEREAS, the end-user was instructed to conduct a mandatory review of the terms and conditions, specifications and cost estimates for the conduct of the Negotiated Procurement (Two-Failed Biddings) of the project;

WHEREAS, considering that there were two (2) consecutive failures of bidding, the BAC 1 likewise resolved to recommend to the Chairman and Chief Executive Officer the resort to Negotiated Procurement (Two-Failed Biddings) and revision/updating of the 2021 APP;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee (BAC) 1, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare a Failure of Bidding for the Supply and Delivery of One (1) Lot of Beer for SOGs under ITB No. PB20-01-020CORA-09, pursuant to Section 35.1(a) of the 2016 Revised IRR of RA 9184, since no bid was received, and
2. To recommend for approval by the Chairman and Chief Executive Officer the following:
 - a) Resort to Negotiated Procurement (Two-Failed Biddings) for the Supply and Delivery of One (1) Lot of Beer for SOGs with re-posting as provided for in Section 54.2 and Annex H of the IRR of R.A. 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications, including its cost estimates and pursuant to Section 35.5 of the 2016 Revised IRR of R.A. 9184 since there occurred two (2) failed biddings, and
 - b) Revision/updating of the 2021 APP to reflect the change in the Mode of Procurement from Public Bidding to Negotiated Procurement (Two-Failed Biddings).


