**RESOLUTION DECLARING THE FAILURE OF PUBLIC BIDDING AND RECOMMENDING FOR APPROVAL BY THE CHAIRMAN AND CHIEF EXECUTIVE OFFICER OF THE CONDUCT OF REBIDDING**

**WHEREAS**, the Bids and Awards Committee (BAC) 3 has been tasked to handle the procurement of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

**WHEREAS**, the Invitation to Bid (ITB) was posted from December 11, 2020 to January 11, 2021 at the Philippine Government Electronic Procurement System (PhilGEPS) and PAGCOR websites, and in a conspicuous place within the premises of PAGCOR Corporate Annex Office;

**WHEREAS**, copies of the ITB were also sent through electronic mail to prospective bidders listed in the PAGCOR's Registry of Suppliers;

**WHEREAS**, in the Pre-Bid Conference held on December 21, 2020, only one bidder, Manila Jockey Club, Inc., attended the forum;

**WHEREAS**, during the Pre-Bid Conference, the BAC 3 resolved to issue a Bid Bulletin postponing the deadline for the Submission and Receipt of Bids from January 11, 2021 to February 1, 2021;

**WHEREAS**, Bid Bulletin No. 1 dated December 22, 2020 to re-schedule the Submission and Opening of Bids from January 11, 2021 to February 1, 2021 was issued and was posted at the websites of PAGCOR and the PhilGEPS;

**WHEREAS**, said Bid Bulletin was, likewise, sent thru email to prospective bidders;

**WHEREAS**, one bidder, Quinito's Wayfood Services, availed the Bidding Documents;

**WHEREAS**, on February 1, 2021, the deadline for the Submission and Receipt of Bids, no bid was received;

**WHEREAS**, during the same meeting, the BAC 3 resolved to declare a Failure of Public Bidding, since no bid was received and further resolved to proceed with the rebidding of the project;

**WHEREAS**, the BAC 3 instructed the end-user, SOG 5, to conduct a mandatory review of the terms, conditions, specifications and budget for the re-conduct of the procurement process.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee (BAC) 3, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare a Failure of Public Bidding for the Procurement of Food and Beverages for Casino Guests of Carmona Satellite for a Period of Three (3) Years under ITB No. PB21-00-002COR, pursuant to Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, since no bid was received; and
2. To recommend for approval by the Chairman and Chief Executive Officer the conduct of rebidding for the Procurement of Food and Beverages for Casino Guests of Carmona Satellite for a Period of Three (3) Years, with re-posting, pursuant to Section 35.3 of the 2016 Revised IRR of R.A. 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates, pursuant to Section 35.2 of the same IRR.
