INVITATION TO BID FOR THE PROCUREMENT OF F&B PROVIDER FOR CASINO PLAYERS/GUESTS AT MIMOSA under ITB No. PB21-05-009ANGa-07

1. The Philippine Amusement and Gaming Corporation (PAGCOR), through the PAGCOR's Corporate Budget for CY 2021 intends to apply the sum of Nine Million Pesos (₱9,000,000.00), VAT-Exclusive, Zero-Rated Transaction, being the total ABC to payments under the contract for the Procurement of F&B Provider for Casino Players/Guests at Mimosa.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PAGCOR now invites bids for the above Procurement Project. Delivery of the Goods is required to commence effective on the date of receipt by the winning supplier of the Notice to Proceed (NTP) for a period of two (2) years. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from PAGCOR and interested bidders may inspect and obtain further information from the Procurement Section (PS), acting as the BBAC Secretariat, of Casino Filipino - Angeles and/or inspect the Bidding Documents at Mezzanine Floor, Casino Filipino - Angeles, Mc Arthur Highway, Balibago, Angeles City during office hours of PAGCOR from 9:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **July 08, 2021, (Thursday) to July 28, 2021 (Wednesday)** from the given address and website(s) below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, based on the following schedule:

Approved Budget for the Contract	Cost of Bidding Documents (in Philippine Pesos)
500,000.00 and below	500.00
More than 500,000.00 up to 1 Million	1,000.00

“DRAW LOTS,” in the event that two (2) or more bidders have been post-qualified and determined as the bidder having the Lowest Calculated Responsive Bid (LCRB) to determine the final bidder having the LCRB, based on the following procedures:

- a) In alphabetical order, the bidders shall pick one rolled paper.
- b) The lucky bidder who would pick the paper with a “CONGRATULATIONS” remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.

11. The PAGCOR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
