BBAC RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT TO MF COMPUTER SOLUTION

WHEREAS, Casino Filipino-Bacolod has a requirement for public bidding for the Supply and Delivery of Surveillance Equipment with a total Approved Budget for the Contract (ABC) of Four Million Four Hundred Seventy-Five Thousand Six Hundred Thirty-One Pesos & 18/100 (PhP4,475,631.18), VAT Exclusive, Zero-Rated Transaction, included in the 2021 APP of CF-Bacolod's and it was approved last January 28, 2021;

WHEREAS, the Requisition Voucher (RV), Terms of Reference (TOR) and other pertinent documents were received by the branch Procurement Section on April 1, 2021;

WHEREAS, in the Pre-Procurement Conference last April 6, 2021, BBAC, CF-Bacolod evaluated all the documents presented, including the technical specifications / TOR integrated in the Bidding Document, wherein necessary modifications were discussed. The BBAC members agreed that the ABC of the project shall be Four Million Four Hundred Seventy-Five Thousand Six Hundred Thirty-One Pesos & 18/100 (PhP4,475,631.18), VAT Exclusive, Zero-Rated Transaction, with approved budget in the total amount of Four Million Five Hundred Three Thousand One Hundred Forty-Nine Pesos & 30/100 (PhP4,503,149.30) as stated in the approved 2021 APP;

WHEREAS, in the same meeting, BBAC resolved to proceed with the finalization of the Bidding Documents for the project and posting of the requirement having noted that the rest of the documents were found to be in order;

WHEREAS, the Invitation to Bid (ITB) was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR-CF-Bacolod from April 9, 2021 to April 30, 2021, and also hand-carried and sent through fax to prospective bidders:

- f) Philippine Government and Electronic Procurement System (PhilGEPS) Registration Certificate with Registration No. 20071016927762203288 valid until March 23, 2022.

WHEREAS, the branch Procurement Section also ascertained the following to be compliant and in order:

- a) **MF COMPUTER SOLUTION** submitted a Net Financial Contracting Capacity (NFCC) computation in the amount of (PhP28,632,445.00) and upon recomputation based on the EFPS-filed Annual ITR for CY 2020, the amount is more than the required NFCC of the project; and
- b) Notarized Bid Securing Declaration submitted by **MF COMPUTER SOLUTION** was confirmed authentic and in order as provided in the template under Section VIII. Bidding Forms of the Bidding Documents.

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by MF COMPUTER SOLUTION the bidder having the Lowest Calculated Bid, was determined to have passed all the criteria for the eligibility, technical and financial requirements was found to be responsive.

NOW, THEREFORE, we, the members of the BBAC, CF-Bacolod, hereby **RESOLVED**;

a) To declare **MF COMPUTER SOLUTION.** as the bidder having the Lowest Calculated Responsive Bid for the Supply and Delivery of Surveillance Equipment. ITB No. PB21-04-004BAC;
