RESOLUTION DECLARING THE FAILURE OF REBIDDING AND RECOMMENDING APPROVAL OF THE RESORT TO NEGOTIATED PROCUREMENT (TWO FAILED BIDDINGS) AND REVISION / UPDATING OF 2021 ANNUAL PROCUREMENT PLAN (APP)

WHEREAS, the Bids and Awards Committee (BAC) 2 has been tasked to handle the procurement requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the above-mentioned requirement was previously procured through public bidding under ITB No. PB20-04-034COR but unfortunately resulted into a failure;

WHEREAS, the Invitation to Bid (ITB) was posted at the websites of PAGCOR and the Philippine Government Electronic Procurement System (PhilGEPS), as well as, in a conspicuous bulletin board within the premises of PAGCOR Corporate Annex Office from November 24, 2020 to December 14, 2020;

WHEREAS, copies of the ITB were sent to twenty-six (26) prospective bidders through electronic mail;

WHEREAS, in a Pre-Bid Conference held on December 02, 2020, no prospective bidder attended the said forum;

WHEREAS, no prospective bidder bought the Bidding Documents for the project;

WHEREAS, on the deadline for the Submission and Receipt of Bids held on December 14, 2020, no prospective bidder submitted its bid;


WHEREAS, in the same meeting, the BAC 2 resolved to declare a Failure of Public Bidding since no bids were received, and further resolved to recommend the resort to Negotiated Procurement (Two Failed Biddings), as provided for in Section 53.1 and Annex H of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, and upon the recommendation of the end-user, the Information and Technology Department (ITD);

WHEREAS, the BAC 2 instructed the end-user, ITD, to revise the Project Procurement Management Plan (PPMP) to reflect the change in the mode of procurement to Negotiated Procurement (Two Failed Biddings) for the subsequent revision of the 2021 Annual Procurement Plan (APP);

NOW, THEREFORE, We, the Members of the Bids and Awards Committee (BAC) 2, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- 1) To declare a Failure of Public Bidding for the Procurement of Two (2) Year Subscription for Two (2) Lots of Mobile Postpaid and Prepaid Plan for PAGCOR Officers and Key Personnel under ITB No. PB21-00-003CORa pursuant to Section 35.1(a) of the 2016 Revised IRR of RA 9184 since no bid was received;
- 2) To recommend for approval by the Chairman and Chief Executive Officer the resort to Negotiated Procurement (Two Failed Biddings) pursuant to Section 35.5 of the 2016 Revised IRR of RA 9184 with re-posting as provided for in Section 54.2, after the conduct of mandatory review and evaluation of terms, conditions and specifications in the bidding documents, including its cost estimates, pursuant to Section 35.3 and Annex H of the same IRR; and
- 3) To revise/update the 2021 Annual Procurement Plan (APP) to reflect Negotiated Procurement (Two Failed Biddings) as the new mode of procurement for the said requirement.


