# ***Glossary of Acronyms, Terms, and Abbreviations***

**ABC** –Approved Budget for the Contract.

**BAC** – Bids and Awards Committee.

**Bid** – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

**Bidder** – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

**Bidding Documents** – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

**BIR** – Bureau of Internal Revenue.

**BSP** – Bangko Sentral ng Pilipinas.

**Consulting Services** – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

**CDA** - Cooperative Development Authority.

**Contract** – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

**CIF** – Cost Insurance and Freight.

**CIP** – Carriage and Insurance Paid.

**CPI** – Consumer Price Index.

**DDP** – Refers to the quoted price of the Goods, which means “delivered duty paid.”

**DTI** – Department of Trade and Industry.

**EXW** – Ex works.

**FCA** – “Free Carrier” shipping point.

**FOB** – “Free on Board” shipping point.

**Foreign-funded Procurement or Foreign-Assisted Project**–Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

**Framework Agreement** – Refers to a written agreement between a procuring entity and a supplier or service provider that identifies the terms and conditions, under which specific purchases, otherwise known as “Call-Offs,” are made for the duration of the agreement. It is in the nature of an option contract between the procuring entity and the bidder(s) granting the procuring entity the option to either place an order for any of the goods or services identified in the Framework Agreement List or not buy at all, within a minimum period of one (1) year to a maximum period of three (3) years. (GPPB Resolution No. 27-2019)

**GFI** – Government Financial Institution.

**GOCC** –Government-owned and/or –controlled corporation.

**Goods** – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term “related” or “analogous services” shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

**GOP** – Government of the Philippines.

**GPPB** – Government Procurement Policy Board.

**INCOTERMS** – International Commercial Terms.

**Infrastructure Projects** – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports, seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

**LGUs** – Local Government Units.

**NFCC** – Net Financial Contracting Capacity.

**NGA** – National Government Agency.

**PhilGEPS** - Philippine Government Electronic Procurement System.

**Procurement Project** – refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

**PSA** – Philippine Statistics Authority.

**SEC** – Securities and Exchange Commission.

**SLCC** – Single Largest Completed Contract.

**Supplier** – refers to a citizen, or any corporate body or commercial company duly organized and registered under the laws where it is established, habitually established in business and engaged in the manufacture or sale of the merchandise or performance of the general services covered by his bid. (Item 3.8 of GPPB Resolution No. 13-2019, dated 23 May 2019). Supplier as used in these Bidding Documents may likewise refer to a distributor, manufacturer, contractor, or consultant.

# ***Section I. Invitation to Bid***



**INVITATION TO BID FOR SUPPLY AND DELIVERY OF FOOD AND BEVERAGES FOR CASINO CUSTOMER, PLAYERS AND GUESTS FOR THREE (3) YEARS FOR MGO SATELLITE under ITB No. PB21-04-006WIN**

1. The Philippine Amusement and Gaming Corporation (PAGCOR), through the PAGCOR's Corporate Budget for CY 2021 intends to apply the Approved Budget for the Contract (ABC) of **Fourteen Million Seven Hundred Thousand Pesos (PhP14,700,000.00), VAT Exclusive, Zero-Rated Transaction** to payments under the contract for the Supply and Delivery of Food and Beverages for Casino Customer, Players and Guests for three (3) years for MGO satellite.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PAGCOR now invites bids for the above Procurement Project. Delivery of the Goods and Services shall be for a period of three (3) years and shall commence from the date of receipt of the winning bidder of the Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from PAGCOR and interested bidders may inspect and obtain further information from the Procurement Section (PS), acting as the BAC Secretariat, of PAGCOR and/or inspect the Bidding Documents at the sixth (6th) Floor, Procurement Section, CF-Winford, Ronquillo Satellite, 561 Ronquillo Street corner Rizal Avenue Sta. Cruz, Manila during office hours of PAGCOR from 9:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **May 31, 2021 (Monday) to June 21, 2021 (Monday)** from the given address

and website(s) below upon payment of **Twenty-Five Thousand Pesos (PhP25,000.00)** for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

PAGCOR shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through electronic means.

Prospective bidders may also download the Bidding Documents free of charge from [www.pagcor.ph](http://www.pagcor.ph) and [www.philgeps.gov.ph](http://www.philgeps.gov.ph) and may be allowed to submit bids provided that bidders pay the applicable fee of the Bidding Documents not later than the deadline for the submission and receipt of bids.

In effecting payment for the Bidding Documents, prospective bidders shall present either the Payment Slip, which may be secured from the PS, or a copy of this Invitation to Bid (ITB) to PAGCOR's Cashier, located at the Third (3<sup>rd</sup>) Floor, Human Resource Section Office, 561 Ronquillo Street corner Rizal Avenue Sta. Cruz, Manila.

6. The PAGCOR will hold a Pre-Bid Conference on **June 8, 2021, Tuesday, 10:00 a.m. at the Conference Room, third (3<sup>rd</sup>) Floor, CF-Winford, Ronquillo Satellite, 561 Ronquillo Street corner Rizal Avenue Sta. Cruz, Manila**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission on or before **June 21, 2021 (Monday), 10:00 a.m. at the Conference Room, Third (3<sup>rd</sup>) Floor, CF-Winford, Ronquillo Satellite, 561 Ronquillo Street corner Rizal Avenue Sta. Cruz, Manila**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **June 21, 2021 (Monday), 10:00 a.m. onwards at the Conference Room, Third (3<sup>rd</sup>) Floor, CF-Winford, Ronquillo Satellite, 561 Ronquillo Street corner Rizal Avenue Sta. Cruz, Manila**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Bidders shall bear all costs associated with the preparation and submission of their bids, and PAGCOR will in no case, be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

Bidders should note that PAGCOR will accept bids only from those that have paid the applicable fee for the Bidding Documents.

PAGCOR assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.

In accordance with Government Procurement Policy Board (GPPB) Circular 06-2005 - Tie-Breaking Method, the Casino Filipino- Winford Branch Bids and Awards Committee (BBAC) shall use a non-discretionary and non-discriminatory measure based on sheer luck or chance, which is "DRAW LOTS," in the event that two (2) or more bidders have been post-qualified and



determined as the bidder having the Lowest Calculated Responsive Bid (LCRB) to determine the final bidder having the LCRB, based on the following procedures:

- a) In alphabetical order, the bidders shall pick one rolled paper.
  - b) The lucky bidder who would pick the paper with a “CONGRATULATIONS” remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.
11. The PAGCOR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

## ***Section II. Instructions to Bidders***

## 1. Scope of Bid

The Procuring Entity, Philippine Amusement and Gaming Corporation (PAGCOR), wishes to receive Bids for the Supply and Delivery of Food and Beverages for Casino Customer, Players and Guests for three (3) years for MGO Satellite under ITB No.: PB21-04-006WIN **with an ABC of Fourteen Million Seven Hundred Thousand Pesos (PhP14,700,000.00)**, VAT Exclusive, Zero-Rated Transaction.

## 2. Funding Information

- 2.1. The GOP through the source of funding as indicated below for CY 2021 in the ABC of **Fourteen Million Seven Hundred Thousand Pesos (PhP14,700,000.00)**, VAT Exclusive, Zero-Rated Transaction.
- 2.2. The source of funding is the Corporate Operating Budget – PAGCOR's Corporate Budget for CY 2021.

## 3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

## 4. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

## 5. Eligible Bidders

- 5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.

- 5.2. Foreign ownership limited to those allowed under the rules may participate in this Project.
- 5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to at least fifty percent (50%) of the ABC.
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

## **6. Origin of Goods**

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under **ITB** Clause 18.

## **7. Subcontracts**

- 7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than twenty percent (20%) of the Project.

The Procuring Entity has prescribed that Subcontracting is not allowed.

## **8. Pre-Bid Conference**

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address, Conference Room, Third (3<sup>rd</sup>) Floor, CF-Winford, Ronquillo Satellite, 561 Ronquillo Street corner Rizal Avenue Sta. Cruz, Manila as indicated in paragraph 6 of the **IB**.

## **9. Clarification and Amendment of Bidding Documents**

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

## **10. Documents comprising the Bid: Eligibility and Technical Components**

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 10.2. The Bidder's SLCC as indicated in **ITB** Clause 5.3 should have been completed within three (3) years prior to the deadline for the submission and receipt of bids.

- 10.3. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.

## **11. Documents comprising the Bid: Financial Component**

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 11.2. If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.
- 11.3. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.4. For Foreign-funded Procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

## **12. Bid Prices**

- 12.1. Prices indicated on the Price Schedule shall be entered separately in the following manner:
  - a. For Goods offered from within the Procuring Entity's country:
    - i. The price of the Goods quoted EXW (ex-works, ex-factory, ex-warehouse, ex-showroom, or off-the-shelf, as applicable);
    - ii. The cost of all customs duties and sales and other taxes already paid or payable;
    - iii. The cost of transportation, insurance, and other costs incidental to delivery of the Goods to their final destination; and
    - iv. The price of other (incidental) services, if any, listed in e.
  - b. For Goods offered from abroad:

- i. Unless otherwise stated in the **BDS**, the price of the Goods shall be quoted delivered duty paid (DDP) with the place of destination in the Philippines as specified in the **BDS**. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible country. Similarly, the Bidder may obtain insurance services from any eligible source country.
- ii. The price of other (incidental) services, if any, as listed in **Section VII (Technical Specifications)**.

### **13. Bid and Payment Currencies**

13.1. For Goods that the Bidder will supply from outside the Philippines, the bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies, shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.

13.2. Payment of the contract price shall be made in Philippine Pesos.

### **14. Bid Security**

14.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.

14.2. The Bid and bid security shall be valid for one hundred twenty (120) calendar days from the date of the Submission, Opening and Preliminary Examination of Bids. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

### **15. Sealing and Marking of Bids**

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

## 16. Deadline for Submission of Bids

- 16.1. The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 7 of the **IB**.

## 17. Opening and Preliminary Examination of Bids

- 17.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

- 17.2. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

## 18. Domestic Preference

- 18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.

## 19. Detailed Evaluation and Comparison of Bids

- 19.1. The Procuring BAC shall immediately conduct a detailed evaluation of all Bids rated "*passed*," using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of RA No. 9184.
- 19.2. If the Project allows partial bids, bidders may submit a proposal on any of the lots or items, and evaluation will be undertaken on a per lot or item basis, as the case may be. In this case, the Bid Security as required by **ITB** Clause 15 shall be submitted for each lot or item separately.
- 19.3. The descriptions of the lots or items shall be indicated in **Section VII (Technical Specifications)**, although the ABCs of these lots or items are indicated in the **BDS** for purposes of the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184. The NFCC must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder.
- 19.4. The Project shall be awarded as One Project having several items grouped into several lots, which shall be awarded as separate contracts per lot.

- 19.5. Except for bidders submitting a committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation, all Bids must include the NFCC computation pursuant to Section 23.4.1.4 of the 2016 revised IRR of RA No. 9184, which must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder. For bidders submitting the committed Line of Credit, it must be at least equal to ten percent (10%) of the ABCs for all the lots or items participated in by the prospective Bidder.

## **20. Post-Qualification**

- 20.2. ## DRAFT SERVICE CONTRACT

This SERVICE CONTRACT is entered into and executed by and between:

**PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)**, a government owned and controlled corporation created and existing by virtue of Presidential Decree 1869, as amended, with office address at the PAGCOR Executive Office, M.H Del Pilar cor. Pedro Gil Sts. Malate, Manila, represented in this act by its \_\_\_\_\_, \_\_\_\_\_, hereinafter referred to as "**PAGCOR**";

Each referred to as a "**PARTY**" and collectively as the "**PARTIES**"

The parties warrant that they are duly organized, registered, validly existing and in good standing under the laws of the Republic of the Philippines, and that the parties and their representatives are capable and have the requisite power, authority, permits, clearances and licenses, to enter into this Service Contract and to perform the Services and all of their obligations under this Service Contract.

### RECITALS:

**WHEREAS, PAGCOR has a** requirement for the Supply and Delivery of Food and Beverages for Casino Customer, Players and Guests for three (3) years for MGO satellite under ITB No.: PB21-04-006WIN (hereinafter referred to as "the Services");

**WHEREAS, PAGCOR** conducted public bidding in accordance with Republic Act (RA) 9184 (Government Procurement Reform Act) and its 2016

Revised Implementing Rules and Regulations (IRR) on \_\_\_\_\_ for the procurement of the Services;

**WHEREAS**, the **CONTRACTOR** has submitted the Single/Lowest Calculated Responsive Bid for the Services;

**WHEREAS**, **PAGCOR** has accepted the bid of the **CONTRACTOR**, subject to the terms and conditions hereunder stipulated;

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the parties agree as follows:

**ARTICLE I**  
**SCOPE OF UNDERTAKING**

The **CONTRACTOR** undertakes to provide the Services, in accordance with the following technical specifications:

<b>Supply and Delivery of Food and Beverages for Casino Customer, Players and Guests for three (3) years for MGO satellite</b>
<b>Description</b>
The <b>SERVICE PROVIDER</b> undertakes to provide the Services, specifically, the provision of food and beverages and the incidental services for sanitation and cleaning, including all the necessary labor, materials, supplies and equipment, to <b>PAGCOR</b> customers, players and guests at Casino Filipino Winford - MGO Satellite, in accordance with the following technical specifications and menu duly attached as Annex "A"
The menu price shall be VAT-Exclusive and zero-rated and shall already include all applicable fees and charges.
The <b>SERVICE PROVIDER</b> shall not amend the menu without the prior written consent of <b>PAGCOR</b> . The prices herein agreed shall not be subject to any increase or upward adjustment for any reason cause whatsoever for the duration of the Contract
18. The <b>SERVICE PROVIDER</b> shall be responsible for the cleanliness and the sanitation of the F&B area.
19. The <b>SERVICE PROVIDER</b> shall have sufficient manpower to provide the Services and shall own, legally possess and/or have access to all the necessary kitchen and restaurant supplies, utensils, equipment necessary for the delivery of the Service, such as, but not limited to: <ul style="list-style-type: none"> <li>a. Spoons, forks, knives and chopping boards;</li> <li>b. Plates, glasses, cups and saucers;</li> <li>c. Various cook wares</li> <li>d. Various tablecloths and napkins;</li> </ul>

<p>e. Stoves, ovens, microwave ovens, grills; and  f. Spices and clean containers for the different food ingredients.</p>
<p>20. The <b>SERVICE PROVIDER</b> shall have good title to the items/goods/services being offered and full authority to sell and transfer the same and that the items/goods/services are sold free and clear of all liens, encumbrances, liabilities and adverse claims of every nature and description.</p>
<p>21. The <b>SERVICE PROVIDER's</b> utensils shall be sterilized, kept clean and dried properly.</p>
<p>22. The <b>SERVICE PROVIDER</b> shall provide the Services twenty-four (24) hours a day, seven (7) days a week or in accordance with the operations of CF Winford- MGO Satellite.</p>
<p>23. The goods and services provided by the <b>SERVICE PROVIDER</b> shall comply with <b>PAGCOR's</b> standards and shall always take into consideration the special preferences of <b>PAGCOR</b>, its customers/clientele and /or guests.</p>
<p>24. The <b>SERVICE PROVIDER</b> shall ensure that its personnel are always well mannered, courteous, polite, efficient and shall conduct themselves, at all times, in a professional manner towards <b>PAGCOR</b>, its directors, officers, agents, customers and guests.</p>
<p>25. The <b>SERVICE PROVIDER's</b> personnel shall secure from the responsible government agency a health/sanitary permit/clearance. The <b>SERVICE PROVIDER</b> shall not field any of its personnel without the requisite government health/sanitary permit/clearance.</p>
<p>26. The <b>SERVICE PROVIDER</b> shall ensure that its personnel exercise good personal hygiene, particularly, but not limited to:</p> <ul style="list-style-type: none"> <li>a) Regular and proper hand washing;</li> <li>b) Clean and well trimmed fingernails without nail polish;</li> <li>c) Hair should be neat and tidy; and</li> <li>d) Open wounds should be properly dressed</li> </ul>
<p>27. The <b>SERVICE PROVIDER's</b> personnel shall, at all times, wear their prescribed uniform including, but not limited to, aprons, headdress/hair caps/hairnet and gloves, which shall be provided by the <b>SERVICE PROVIDER</b>.</p>
<p>28. <b>PAGCOR</b> may require the replacement of any <b>SERVICE PROVIDER's</b> personnel who is not performing his/her duties responsibilities to <b>PAGCOR's</b> satisfaction. The <b>SERVICE PROVIDER</b> shall not unilaterally pull out any of its personnel without the conformity of <b>PAGCOR</b>.</p>
<p>29. In the event that the <b>SERVICE PROVIDER</b> fails to comply with any of its undertakings, as set forth in this Service Contract, <b>PAGCOR</b> shall be released from its obligations under this Service Contract, without prejudice to its rights of restitution, recovery and damages.</p>

30. This Service Contract, and all the rights and interests herein, may not be assigned or sub-contracted to another without the consent of the other party.
31. In the event that facts and circumstances arise or are discovered which render this Contract disadvantageous to the Government, as determined by <b>PAGCOR</b> , the Parties hereto agree to immediately to re-negotiate its terms and conditions, or at the option of <b>PAGCOR</b> , terminate the same.
32. This Service Contract constitutes the entire agreement between the parties pertaining to the subject matter contained in it and supersedes all prior and contemporaneous contracts, representations, warranties and understandings of the parties. No supplement, variation or amendment to this Service Contract shall be binding unless executed in writing by all parties thereto.
<b>ADDITIONAL TECHNICAL SPECIFICATIONS QUALIFICATIONS OF THE CONTRACTOR:</b>
1. The <b>SERVICE PROVIDER</b> should be located within MGO Satellite but outside of <b>PAGCOR</b> leased area. No rental shall be charged by <b>PAGCOR</b> .
2. The <b>SERVICE PROVIDER</b> must have at least three (3) years experience in the restaurant industry.
The <b>SERVICE PROVIDER</b> should be able to serve cuisine to cater to different types of nationalities & food preferences.
3. The personnel of the <b>SERVICE PROVIDER</b> shall observe the practice of “clean as you go” policy.
4. The <b>SERVICE PROVIDER</b> shall exercise prompt delivery of service when order is placed.
<b>FOOD HANDLING:</b>
1. Usage of gloves by kitchen personnel must be observed at all times (gloves for dry/raw food must not be used to serve wet/cooked food).
2. Salads that are prepared in advance must be properly stored & transported in cold temperature.
3. Heating of food must be available upon the request.
4. Chopping boards must not be used interchangeably for raw and cooked foods.
5. Wooden chopping boards should not be used.
6. If food will be cooked in a different location, the Service Provider must transport food that is tightly covered at least thirty (30) minutes before the service.
7. The service provider should provide international cuisine (like American, Chinese, Korean) to cater to the different nationalities and food preferences of the customers, guests and patrons of the Casino.
<b>MENU:</b>

1. The menu should include viands using the different methods of cooking (grilled, fried, and steamed).
2. Color combinations & Food presentation must be observed.
3. The Service Provider should be able to cater to a varied number of customers and different functions with a set menu/package.
<b>ACTUAL FOOD DELIVERY:</b>
1. Food served must not appear too oily, dry or soaked in its own fat.
2. Hot food should be served hot, cold food should be served cold
3. Food arrangement should be attractive & garnished.
<b>F&amp;B CONTRACT PRICE and SCHEDULE OF PAYMENT:</b>
1. The total contract price for this Service Contract shall be Fourteen Million Seven Hundred Thousand Pesos ( <b>PHP14,700,000.00</b> ), VAT Exclusive Zero-Rated Transaction, for a period of three (3) years or upon exhaustion of the contract price, whichever comes first (the "Contract Price").
2. Payment shall be based on actual consumption and billing and shall be subjected to the appropriate withholding taxes.
3. <b>PAGCOR</b> shall not be under any obligation to pay the <b>SERVICE PROVIDER</b> the entire amount of the Budget. Moreover, the aggregate billings under this Contract shall not exceed the total Contract Price.
4. The <b>SERVICE PROVIDER</b> shall submit a VAT exclusive, zero-rated billing statement to CF- Winford's Accounting Office at Ronquillo Satellite, 561 Ronquillo Street corner Rizal Avenue, Sta. Cruz, Manila on a weekly basis together with the corresponding coupons/invoices duly signed by a qualified guests or officers of <b>PAGCOR</b> and countersigned by a duly authorized <b>PAGCOR</b> representative, if applicable. However, F&B items/billings found unsatisfactory and/or not conformed to by <b>PAGCOR</b> shall not be paid. <b>PAGCOR</b> shall pay the billing statement within thirty (30) calendar days from its receipt of the billing statement provided that any additional, necessary and/or required supporting documents are submitted by the <b>SERVICE PROVIDER</b> and are verified by <b>PAGCOR</b> .
5. <b>PAGCOR</b> shall not be liable for any other costs except as provided for under this Contract.
<b>CONTRACT TERM</b>
1. This Contract shall commence from the date of receipt of the winning bidder of the Notice to Proceed for a period of three (3) years or upon exhaustion of the contract price, whichever comes first.
2. <b>PAGCOR</b> may terminate this Contract with or without cause, without need for judicial intervention, and without incurring any obligation whatsoever, upon thirty (30) days written notice to the <b>SERVICE PROVIDER</b> .



3. Should the **SERVICE PROVIDER** incur delay in the performance of its obligations, **SERVICE PROVIDER** shall pay a penalty of one-tenth of one percent (1/10 of 1%) of the unperformed portion of the contract for each day of delay, including Sundays and Holidays, beyond the specific period. The maximum deduction shall be ten percent (10%) of the amount of the Contract. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the Service Contract. **PAGCOR** shall have the option to rescind the Contract, without prejudice to other courses of action and remedies open to it.

4. In case the **SERVICE PROVIDER** still fails to deliver the Services after the lapse of thirty (30) days from the supposed date of implementation as provided for in this Contract, **PAGCOR** shall have the option to terminate the Contract, without prejudice to other courses of action and remedies open to it.

**OTHER QUALIFICATIONS:**

1. The **SERVICE PROVIDER** shall be responsible for the following:

- a. Improvement on the dining area and space occupied by the Service Provider. All costs shall be for the account of the Service Provider subject to the existing guidelines adopted and contract obligations complied by **PAGCOR**.
- b. Refurbishment of furniture and fixtures including lighting fixtures in the dining area shall be for the account of the Service Provider.
- c. Payment of Utility Charges. All electricity and water bills and other charges necessary and incidental to the operation of the Service Provider shall be for its account.

2. The Service Provider must submit a notarized Certification or Contract from the building owner stating that the bidder will be allowed to do business within the building where the casino is housed in the event that he will be awarded the procurement project.

A notarized contract that is valid for the duration to the procurement project shall be submitted within ten (10) calendar days upon receipt of the Notice of Award (NOA).

3. The Service Provider must not use disposable plates, spoons forks, cups and glasses. However, these must be available upon the request of the customer/guest.

4. The minimum period of warranty of goods/items must not be less than three (3) months expiry date.

5. The **SERVICE PROVIDER** must provide tablets for the establishment and utilize Restaurant order App/Menu Management App to facilitate a faster delivery of services to the customers, guests and players.

6. The Service Provider should provide Casino customers with purified bottled drinking water with their meals.

**ADDITIONAL GUIDELINES:**

The Service Provider should submit a copy of the Health and Safety Protocols and/or Guidelines that they will be implementing which shall be in accordance with the IATF Guidelines (i.e. Section 8, Food and Beverage (F&B) Service; Section 9, Kitchen Sanitation and Disinfection and of Section 14, Supplier of Goods and Services per Health and Safety Guidelines Governing the Operations of Accommodation Establishments under the New Normal)

**ARTICLE II**  
**CONTRACT AMOUNT**

The prices herein agreed upon shall not be subject to any increase or upward adjustment for any reason or cause whatsoever for the duration of the Contract.

**ARTICLE III**  
**SCHEDULE OF PAYMENT**

The **CONTRACTOR** shall post a Performance Security for the benefit of **PAGCOR** as a guarantee for former's compliance with its obligations under this Contract, to the signing hereof, in accordance with any of the following schedule:

The Performance Security shall remain valid until issuance of the last/final certificate of Acceptance. The same may be released only after **PAGCOR's** conformity with the last / final Certificate of Performance submitted by the **CONTRACTOR** in accordance with Article I herein and provided that there are no claims filed against the **CONTRACTOR** or the surety company.

**ARTICLE V**  
**CONTRACT TIME**

The Contract shall be for a period of three (3) years and shall commence within Sixty (60) calendar days from the date of receipt by the winning supplier of the Notice to Proceed. Within this period, **PAGCOR** may terminate this Contract with or without cause, without need for judicial intervention, upon thirty (30) days written notice to the **CONTRACTOR**.

**ARTICLE VI**  
**CLAIMS AND DISPUTES**

All claims and disputes relating to or arising out of this Contract shall as much as possible, be settled amicably by the **PARTIES** before resorting to any judicial action.

If the **PARTIES** fail to settle their differences or disputes, the **PARTIES** waiving for the purpose any other venue, hereby agree that the courts of the City of Manila shall be the exclusive venue of any or all actions or suits between the **PARTIES** to the exclusion of all other courts and venues. This provision shall apply even in cases for declaration of nullity of this Contract in its entirety or in part and in cases arising after or by reason of the declaration of nullity of this Contract in its entirety or in part.

In the event that a dispute arises with respect to this Contract, the **PARTY** prevailing in such dispute shall be entitled to recover all expenses, including, without limitation, reasonable attorneys' fees and expenses, incurred in ascertaining such **PARTY's** rights or in preparing to enforce, or in enforcing, such **PARTY's** rights under this Contract, whether or not it was necessary for such **PARTY** to institute suit.

**ARTICLE VII**  
**INDEMNIFICATION**

The **CONTRACTOR** hereby holds **PAGCOR** its guests, corporate affiliates, directors, officers, employees and agents free and harmless of any and all actions or liabilities arising out of this Service Contract, including, without being limited to, claims

for unpaid and back wages, regularization and other terms and conditions of employment, as well as civil and criminal liabilities that the **CONTRACTOR** and/or **PAGCOR** may incur as a result of, or arising out of the conduct and/or pursuit of the Services. The **CONTRACTOR** shall indemnify **PAGCOR** for any costs which may arise from defending any action, suit or proceedings, including legal fees or other expenses incurred in relation to any such claims mentioned above.

The **CONTRACTOR** agrees to protect and to exercise due care and proper handling of the properties of **PAGCOR** during the performance of the Services. The **CONTRACTOR** shall be jointly and severally liable with its personnel and shall indemnify and hold **PAGCOR** free and harmless for any death, injury or damage to **PAGCOR** and to third person, loss, breakage or destruction of properties, as a consequence of the **CONTRACTOR** and its personnel's acts, omissions, willful intent or negligence in the performance of the Services or its obligations under this Service Contract.

The **CONTRACTOR** shall be liable in case of theft, robbery, or any loss to **PAGCOR** as a result of the Services provided by the **CONTRACTOR** and its personnel. The **CONTRACTOR** hereby agrees to replace, repair or retribute any loss involving its personnel and the performance of its Services.

#### **ARTICLE VIII** **DAMAGES FOR DELAY**

Should the **CONTRACTOR** incur delay in delivery and/or replacement of plants in accordance with Article I hereof, the **CONTRACTOR** shall pay a penalty of one-tenth of one percent (1/10 of 1%) of the total cost of the unperformed portion for every day of delay, including Sundays and Holidays, beyond the specific period.

In case the **CONTRACTOR** still fails to deliver and/or replace the plants after the lapse of thirty (30) days from the supposed date of delivery and/or replacement provided by **PAGCOR**, in addition to the penalties agreed upon, **PAGCOR** shall have the option to terminate the agreement.

#### **ARTICLE IX** **DEFAULTS**

In the event that any of the **PARTIES** fail to comply in good faith with their undertakings, as set forth in this Contract, within the periods provided herein, the non-defaulting party shall be released from its obligations under this Contract, without prejudice to the rights of restitution, recovery and damages.

In the event of breach by either party, the **PARTIES** agree to amicably settle the same under the provisions of Article VI hereof prior to judicial action.

In the event settlement cannot be made, the **PARTIES** shall abide by the provisions of law with respect to default.

#### **ARTICLE X**

## TAXES AND LICENSES

All amounts, claims, and expenses pertaining to licenses, permits, registrations or renewals thereof, required by the appropriate government entities for the services performed under the Contract shall be for the exclusive account of the **CONTRACTOR**.

Any accident, injury, or sickness of any kind, or death that may occur to any employee of the **CONTRACTOR** during the time and consequent to the performance of the work under this Contract shall likewise be the **CONTRACTOR**'s responsibility.

4. If any provision hereof is prohibited or made unenforceable under any applicable law or by a competent court or authority, the same shall not affect any other provision of this Contract, which are otherwise valid and enforceable.
5. The relationship between the **PARTIES** shall be limited to the performance of the terms and conditions of the Contract. Nothing in this Contract shall be construed

to create a general partnership between the **PARTIES**, or to authorize any **PARTY** to bind the other except as set forth in this Contract, or to borrow money on behalf of another **PARTY**, or to use the credit of any **PARTY** for any purpose other than what has been set forth herein.

6. Any right or remedy conferred by this Contract upon the **PARTIES** shall not be exclusive of any other right or remedy, whether under this Contract or provided or permitted to the parties at law or in equity, but each right or remedy shall be cumulative of every other right or remedy available to them.

This Contract constitutes the entire agreement between the **PARTIES** pertaining to the subject matter contained in it, and supersedes all prior and contemporaneous agreements, representations, warranties and understandings of the parties. No supplement, variation or amendment of this Contract shall be binding unless executed in writing by all **PARTIES** thereto.

No waiver of any of the provisions of this Contract shall be deemed, or shall constitute a waiver of any other provision, whether similar or nor similar, nor shall any waiver constitute a continuing waiver. No waiver shall be binding unless in writing and signed by the **PARTY** making the waiver.
