WHEREAS, this refers to the negotiated procurement (two failed biddings) for the Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. FB21-10-001DAV;

WHEREAS, the ABC for the project is in the total amount of One Million Fifty Thousand Pesos (PhP 1,050,000.00), VAT Exclusive, Zero-Rated Transaction;

WHEREAS, on October 6, 2021, deadline for the Submission of Best Offer, the BBAC of CF- Davao declared a Failure of Negotiated Procurement (Two Failed Bidding), pursuant to Section 35.1 (a) of the IRR of R.A. 9184, which provides that:

No. 9184; and

Re-Conduct of Negotiated Procurement (Two-Failed Biddings) pursuant to Section 35.5 of the IRR of R.A. 9184 which states that: "Should there occur a second failure of bidding, the procuring entity may resort to negotiated procurement, as provided for in Section 53.1 [Negotiated Procurement (Two Failed Biddings)] of the IRR.
