RESOLUTION DECLARING FAILURE OF THE NEGOTIATED PROCUREMENT (SMALL VALUE) AND RE-CONDUCT THEREOF

WHEREAS, the Bids and Awards Committee (BAC) 2 has been tasked to handle the procurement of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the Procurement Processing Request (PPR), approved Annual Procurement Plan (APP) as of July 5, 2021 and other pertinent documents were received by the Procurement Department (PD), acting as the BAC Secretariat, on July 15, 2021;

WHEREAS, in the Pre-Procurement Conference held on August 2, 2021, the BAC 2 together with the representatives of the end-user, SSD, reviewed and evaluated all the documents presented, including the technical specifications integrated in the Request for Quotation (RFQ);

WHEREAS, in the same meeting, BAC 2 instructed the PD to proceed with the finalization and posting of the RFQ;

WHEREAS, the RFQ was posted in a conspicuous place within the premises of PAGCOR Corporate Annex Office, Carmen Bldg., UN Avenue cor. Maria Orosa Sts., Ermita Manila, from August 31 to September 6, 2021, and was also sent through email to prospective bidders from the list of PAGCOR's Registry of Suppliers;

WHEREAS, on the deadline for the Submission and Receipt of Quotations last September 6, 2021, no quotations were received;

WHEREAS, during the Deliberation Meeting held on September 13, 2021, the BAC 2 declared a failure of Negotiated Procurement (Small Value) and resolved to re-conduct the procurement process based on the recommendation of the end-user;

NOW, THEREFORE, WE, the Members of the Bids and Awards Committee (BAC) 2 hereby **RESOLVE**, as it is hereby **RESOLVED**, to declare the following:

1. To recommend the declaration of **FAILURE** of Negotiated Procurement (Small Value) for the Refilling of Fire Extinguishers under ITB No. SV21-08-025COR pursuant to Section 35.1 (a) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184 since no bids were received; and
2. Re-conduct of Negotiated Procurement (Small Value) of the Refilling of Fire Extinguishers under the same terms, conditions and budget for the project.


