**BBAC CF-DAVAO RESOLUTION RECOMMENDING APPROVAL FOR THE

WHEREAS, the Branch Bids and Awards Committee (BBAC) of Casino Filipino (CF)-Davao has been tasked to handle the procurement of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, on October 18, 2022, Tuesday, during the Opening and Preliminary Examination of Bids, no bids were received and the BBAC CF-Davao declared a "Failure of Bidding" in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184;

WHEREAS, the BBAC CF-Davao further recommended for the conduct of a Re-bidding with re-advertisement and/or posting, pursuant to Section 35.3 of the IRR of RA 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates;

WHEREAS, the Branch Manager, as duly delegated by the Board of Directors, approved the conduct of re-bidding on October 24, 2022 for the Supply and Delivery of I.T Equipment ITB No. CB22-09-011DAVa-10;

WHEREAS, on November 17, 2022, during the schedule of Opening and Preliminary Examination of Bids, no bids were received and the BBAC CF-Davao declared a Failure of Bidding in accordance with Sec.35.1.a of the IRR of RA No. 9184, which states:

"Section 35. Failure of Bidding"

35.1. The BAC shall declare the bidding a failure when:
