**WHEREAS**, this refers to the public bidding for the Supply and Delivery of Food & Beverages (F&B) for the Conduct of SM Elite Tournament, Super6 Derby & Party Pit Events;

**WHEREAS**, on the scheduled Opening and Preliminary Examination of Bids on October 17, 2022, no bids were received and the BBAC CF-Davao declared a "Failure of Bidding" in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184;

**WHEREAS**, the BBAC further recommended for the conduct of a Re-bidding with re-advertisement and/or posting, pursuant to Section 35.3 of the IRR of RA 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates;

**WHEREAS**, the Branch Manager, as duly delegated by the Board of Directors, approved the conduct of re-bidding on October 24, 2022 for Supply and Delivery of Food & Beverages (F&B) for the Conduct of SM Elite Tournament, Super6 Derby & Party Pits Events under ITB No. CB22-09-012DAVa-10;

**WHEREAS**, on the scheduled Opening and Preliminary Examination of Bids last November 14, 2022, no bids were received and the BBAC CF-Davao declared a Failure of Bidding in accordance with Sec.35.1.a of the IRR of RA No. 9184, which states:

"Section 35. Failure of Bidding"

35.1. The BAC shall declare the bidding a failure when:
