BBAC CF-DAVAO RESOLUTION RECOMMENDING APPROVAL FOR THE FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS MACHINERY AND EQUIPMENT UNDER ITB NO. CB22-10-013DAV

WHEREAS, the Casino Filipino - Davao Branch Bids and Awards Committee (BBAC) has been tasked to handle the procurement of the requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) Casino Filipino – Davao branch with the project details presented above;

WHEREAS, the Procurement Processing Request (PPR), and other pertinent documents were received by the Procurement Section (PS), acting as the BBAC Secretariat, on October 10, 2022;

WHEREAS, on October 24, 2022, during the Pre-Procurement Conference, the BBAC CF-Davao and representative from the end-user, FMES, reviewed and evaluated all the documents presented, including the Technical Specifications/ Terms of Reference (TOR) integrated in the Bidding Documents;

WHEREAS, the Invitation to Bid was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR Davao from October 26, 2022 to November 15, 2022;

WHEREAS, copies of the Invitation to Bid were also sent through email and fax to prospective bidders;

WHEREAS, no bidder came to attend the Pre-bid Conference held on November 3, 2022;

WHEREAS, one (1) bidder, Tomas Electrical Supply Corp., bought the bidding documents;

WHEREAS, on November 15, 2022, during the Submission, Receipt, Opening and Preliminary Examination of Bids, only one (1) bidder, Tomas Electrical Supply Corp., submitted their bid within the prescribed time;

WHEREAS, after the Opening and Preliminary Examination of First (1st) Bid Envelope (Eligibility and Technical Component of the Bid), the results were as follows:

NAME OF BIDDER	FINDINGS
Tomas Electrical Supply Corp.	Bidder was disqualified due to the following: 1) The PhilGEPS Registration Certificate Annex "A" is not updated. The uploaded Tax Clearance Certificate was expired. 2) There was no name of "Name of contract" stated in the statement of on-going private contracts.

NOW, THEREFORE, We, the Members of the Branch Bids and Awards Committee (BBAC) CF- Davao, hereby **RESOLVE** as it is hereby **RESOLVED**, to declare a "Failure of Bidding" for the Supply and Delivery of Various Machinery and Equipment under ITB No. CB22-10-013DAV pursuant to Section 35.1 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184.


