BBAC CF-DAVAO RESOLUTION RECOMMENDING APPROVAL FOR THE FAILURE OF RE-BIDDING AND CONDUCT OF NEGOTIATED PROCUREMENT (TWO-FAILED BIDDINGS)

WHEREAS, this refers to the public bidding for the Supply and Delivery of Three (3) Years Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite;

WHEREAS, after the Opening and Preliminary Examination of Bids held on December 28, 2021, no bidder submitted their bids and the BBAC CF-Davao declared a "Failure of Bidding" in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184, which states:

"Section 35. Failure of Bidding"

35.1. The BAC shall declare the bidding a failure when:

a) No bids are received; and

WHEREAS, the BBAC further recommend to conduct a re-bidding with re-advertisement and/or posting, pursuant to Section 35.3 of the IRR of RA 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates;

WHEREAS, the Branch Manager, as duly delegated by the Board of Directors, approved the conduct of re-bidding on January 5, 2022 for Supply and Delivery of Three (3) Years

Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. CB22-00-001DAVa-01;

However, after the Opening and Preliminary Examination of Bids held last February 7, 2022, the BBAC CF- declared a Failure of Bidding in accordance with Sec.35.1.a of the IRR of RA No.9184;

NOW, THEREFORE, We, the Members of the Branch Bids and Awards Committee (BBAC) CF- Davao, hereby **RESOLVE** as it is hereby **RESOLVED**, to recommend the following resolutions:

1. Declaration of a "Failure of Bidding" for the Supply and Delivery of Three (3) Years Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. CB22-00-001DAVa-01 pursuant to Section 35.1 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184;
2. Conduct of Negotiated Procurement (Two-Failed Biddings) for the Supply and Delivery of Three (3) Years Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite with re-posting as provided for in Section 54.2 and Annex H (Consolidated Guidelines for Alternative Methods of Procurement) of the IRR of R.A. 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates and pursuant to Section 35.5 of the IRR of R.A. 9184 since there occurred two failed biddings; and
3. Revision/Updating of the 2022 Annual Procurement Plan (APP) to reflect the change in the Mode of Procurement from Competitive/Public Bidding to Negotiated Procurement (Two-Failed Biddings).


