BBAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL TO RESORT TO NEGOTIATED PROCUREMENT (TWO-FAILED BIDDINGS) FOR THE PROCUREMENT OF F&B, DECORATIONS AND PROMOTIONAL MATERIALS FOR MONTHLY MARKETING THEMED EVENTS-LOT 2 (RE-BIDDING) AND REVISION/UPDATING OF THE 2022 APP/PPMP

WHEREAS, the CF-Olongapo BBAC has been tasked to handle the procurement requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the Procurement Processing Request (PPR) supported by Technical Specifications/ Terms of Reference (TOR) and other pertinent documents were received by the Branch Procurement Section (BPS), acting as the BBAC Secretariat, on April 11, 2022;

WHEREAS, in a Pre-Procurement Conference held on April 22, 2021, the CF-Olongapo BBAC and representative from the end-user, Marketing Section (MS), reviewed and evaluated all the documents presented, including the Technical Specifications/ Terms of Reference (TOR) integrated in the Bidding Documents;

WHEREAS, the Invitation to Bid was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Olongapo from April 29, 2022 to May 20, 2022 and also sent through email to prospective bidders;

WHEREAS, in the Pre-Bid Conference held on May 6, 2022, the Committee discussed the salient procedures for the conduct of public bidding and the contents of the Bidding Documents to the authorized representative of New Cherry Blossom Catering Services as prospective bidder who attended the conference;


WHEREAS, no bids were received for Lot 2 of the aforementioned project during the Submission and Opening of Bids held on May 20, 2022:

WHEREAS, on the same day, the CF-Olongapo Branch Bids and Awards Committee (BBAC) with the End-User, resolved to declare the Lot 2 (*Supply and Delivery of Promotional Materials and Decoration*) of the Procurement of F&B, Decorations, and Promotional Materials for Monthly Marketing Themed Events (Re-Bidding) as failure of bidding Pursuant to Section 35.1(a) No Bids are received of 2016 Revised IRR of R.A. 9184.

NOW, THEREFORE, We, the members of the CF – Olongapo Branch Bids and Awards Committee (BBAC), hereby **RESOLVE** as it is hereby **RESOLVED** to recommend to the Officer-In-Charge, as duly delegated by the PAGCOR Board of Directors:

1. *Declare a Failure of Bidding (pursuant to Section 35.1. (a) of 2016 Revised IRR R.A. 9184) for Lot 2 (Supply and Delivery of Promotional Materials and Decoration) of the Procurement of F&B, Decorations, and Promotional Materials for Monthly Marketing Themed Events (Re-Bidding) under ITB No. CB22-03-002OLOa-04;*
2. *Resort to Negotiated Procurement(Two-Failed Biddings) for the Lot 2 Procurement of F&B, Decorations, and Promotional Materials for Monthly Marketing Themed Events (Re-Bidding) with reposting as provided for in Section 54.2 and Annex H) Consolidated Guidelines for Alternative Methods of Procurement) of the IRR of R.A. 9184,after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates and pursuant to Section 35.5 of the IRR of R.A. 9184 since there occurred two failed bidding: and*
3. *Revision/updating of the 2022 APP to reflect Change in Mode of Procurement from Competitive Bidding to Negotiated Procurement (Two-Failed Bidding)*




