**WHEREAS**, the Branch Bids and Awards Committee (BBAC) of Casino Filipino - Davao has been tasked to handle the procurement requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

**WHEREAS**, the Procurement Processing Request (PPR), approved Annual Procurement Plan (APP) 2021 dated December 10, 2021, and Terms of Reference, and Quotations were received by the Branch Bids and Awards Committee (BBAC) Secretariat on December 29, 2021;

**WHEREAS**, in a Pre-Procurement Conference held on January 18, 2021, the BBAC CF-Davao and representative from the end-user, Marketing Section, reviewed and evaluated all the documents presented, including the terms of reference/ scope of work integrated in the Bidding Documents;

**WHEREAS**, the Invitation to Bid was posted at the websites of PAGCOR and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Davao from January 24, 2022 to February 14, 2022, and also sent through email and fax to prospective bidders;

**WHEREAS**, on February 1, 2022 no bidder attended the Pre-bid Conference;

**WHEREAS**, on the deadline for the Submission, Receipt, Opening and Preliminary Examination of Bids on February 14, 2022 no bidder submitted their bids during the scheduled time of submission;

**WHEREAS**, the BBAC of CF- Davao declared a Failure of Bidding in accordance with Section 35.1.a of the IRR of R.A. 9184, which states that:

*"Section 35. Failure of Bidding"*

35.1. *The BAC shall declare the bidding a failure when:*

a) *No bids are received;*
