FAILURE OF NEGOTIATED PROCUREMENT (TWO-FAILED BIDDINGS) AND
RE-CONDUCT THEREOF**

WHEREAS, the Branch Bids and Awards Committee (BBAC) CF-Davao has been tasked to handle the procurement of requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the Request for Quotation (RFQ) was posted at the websites of PAGCOR and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Davao from February 23, 2022 until March 15, 2022, and also sent through email and fax to prospective bidders;

WHEREAS, No bidder attended the Pre-bid Conference held on March;

WHEREAS, on the deadline for the Submission of Best Offer on March 15, 2022, no bidder submitted their quotations during the scheduled time of submission;

WHEREAS, the BBAC CF-Davao declared a "Failure of Bidding" in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184, which states:

"The BAC shall declare the bidding a failure when:

a) No Bids are received;"

NOW, THEREFORE, We, the Members of the Branch Bids and Awards Committee (BBAC) CF- Davao, hereby **RESOLVE** as it is hereby **RESOLVED**, to recommend the following resolutions for the information or further instruction, if any, of the Branch Manager, as duly delegated by the Board of Directors:

1. Declaration of a Failure of Negotiated Procurement (Two Failed Bidding) for the Supply and Delivery of Three (3) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. FB22-02-001DAV, pursuant to Section 35.1 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184; and
2. Re-Conduct of Negotiated Procurement (Two-Failed Biddings) pursuant to Section 35.5 of the IRR of R.A. 9184 which states that: "Should there occur a second failure of bidding, the procuring entity may resort to negotiated procurement, as provided for in Section 53.1 [Negotiated Procurement (Two Failed Biddings)] of the IRR.
