**WHEREAS**, on March 28, 2022, the Branch Manager approved the re-conduct of Negotiated Procurement (Two-Failed Bidding) for the Supply and Delivery of Three (3) Years Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. FB22-02-001DAVa-03;

**WHEREAS**, the Request for Quotation (RFQ) for the aforesaid requirement was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of Casino Filipino–Davao from March 30, 2022 to April 19, 2022;

**WHEREAS**, copies of the RFQ were also sent through email and fax to five (5) prospective bidders;

**WHEREAS**, on the deadline for the Submission of Best Offer on April 19, 2022, no bidders submitted their quotations, hence, the BBAC of CF-Davao declared a Failure of Negotiated Procurement (Two Failed Bidding), pursuant to Section 35.1 (a) of the IRR of R.A. 9184, which provides that:
