**WHEREAS**, the use of Negotiated Procurement (Small Value) was approved by the Board of Directors on April 8, 2022, upon recommendation of the Branch Bids and Awards Committee CF-Olongapo in accordance with Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184 since the amount involved for said project is within the threshold of One Hundred Ninety-One Thousand Two Hundred Eighty-Eight Pesos and 87/100 (PhP191,288.87) as provided under Annex "H" of the same IRR of R.A. 9184;




