BBAC RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT TO A4LUCK MARKETING CORPORATION

WHEREAS, the Branch Bids and Awards Committee (BBAC), CF-Tagaytay has been tasked to handle the procurement requirements of CF-Tagaytay with project details presented above;

WHEREAS, the Requisition Voucher (RV), Copy of the approved Annual Procurement Plan (APP) for CY 2022, Terms of Reference, Quotations and other pertinent documents were received by the Procurement Section on September 09, 2022;

WHEREAS, the project was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and in a conspicuous place within the premises of CF-Tagaytay from September 14, 2022 to September 20, 2022;

WHEREAS, on the deadline for the Submission and Receipt of Quotation, the following bidders submitted their quotation on time:

1. IMAX Technologies Inc;
2. JTM Cable Wring & Computer Accessories;
3. A4 Luck Marketing Corporation;
4. E3K IT Solutions; and
5. Agile Techfrontier Corporation;

WHEREAS, after the Preliminary Examination of Quotation (Eligibility and Technical and Financial Component of the Proposal), **A4LUCK MARKETING CORPORATION** got "Passed" rating;

WHEREAS, the financial offer, as read, of **A4LUCK MARKETING CORPORATION** is within the approved budget amounting of One Hundred Sixteen Thousand Eight Hundred Pesos (PhP116,800.00), VAT Exclusive, Zero Rated Transaction;

WHEREAS, on the same day, the end-user, Information Technology Section in the presence of the Procurement Staff and the Observer (Security Staff) conducted the Detailed Bid Evaluation and Identified **A4LUCK MARKETING CORPORATION** as the bidder having the **Lowest Calculated Quotation (LCQ)** with a financial quotation amounting to One Hundred Sixteen Thousand Eight Hundred Pesos (PhP116,800.00), VAT Exclusive, Zero Rated Transaction;

WHEREAS, on September 23, 2022, the end-user, Information Technology Section submitted an Evaluation Report for the offer of **A4LUCK MARKETING CORPORATION** as the bidder having the **Lowest Calculated Quotation (LCQ)** and stated that the proposal of the bidder is complied

with the end-user's requirement and quotation offer for the project is within the Approved Budget for the Contract (ABC);

WHEREAS, based on the Procurement Department (PD)'s Verification Report dated October 03, 2022 the following documents submitted by **A4LUCK MARKETING CORPORATION** were found to be authentic and valid:

- a) Business Permit for CY 2022
- b) PhilGEPS Registration Certificate;
- c) SEC Registration Certificate; and
- d) Omnibus Sworn Statement

WHEREAS, based on the PD's Verification Report dated October 03, 2022 the submitted Omnibus Sworn Statement by the bidder, as confirmed with the official website of the GPPB, **A4LUCK MARKETING CORPORATION** is not included in the list of blacklisted suppliers.

WHEREAS, during the Deliberation Meeting held on October 07, 2022 the BBAC examined and validated the eligibility, technical and financial quotation of **A4LUCK MARKETING CORPORATION** as presented in the evaluation report of the end-user and post-qualification report for the project and noted that all documents were "Verified" and "Evaluated";

WHEREAS, upon careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder having the **Lowest Calculated Quotation (LCQ)**, the quotation of **A4LUCK MARKETING CORPORATION** was found to be responsive;

WHEREAS, based on the results of the post-qualification process and having passed all the criteria for the eligibility, technical and financial requirements, the BBAC of CF-Tagaytay resolved to recommend the award of contract to **A4LUCK MARKETING CORPORATION** for having the **Lowest Calculated Quotation (LCQ)** for the project;

NOW, THEREFORE, We, the Members of the BBAC, hereby **RESOLVE** as it is hereby **RESOLVED** the following:

- a) To declare **A4LUCK MARKETING CORPORATION** as the bidder having the **Lowest Calculated Quotation (LCQ)** for the **Supply and Delivery of Materials for the Repair and Maintenance of I.T Equipment** under ITB No. **SV22-08-001TAGb-09** and;


