SUBJECT : **NOTICE TO DECLARE THE SUSPENSION OF THE ON-GOING PROCUREMENT ACTIVITIES AND RESUMPTION THEREOF PURSUANT TO GPPB RESOLUTION NO. 09-2020 ENTITLED “APPROVING MEASURES FOR THE EFFICIENT CONDUCT OF PROCUREMENT ACTIVITIES DURING A STATE OF CALAMITY OR IMPLEMENTATION OF COMMUNITY QUARANTINE OR SIMILAR RESTRICTIONS”**

This is to inform you that the Branch Bids and Awards Committee (BBAC) of Casino Filipino – Ilocos Norte resolved to suspend the conduct of the procurement activities of Procurement of Two (2) Lots Annual Medical Examination and Neuropsychological Evaluation Test for Two (2) Years under ITB No. CB22-08-003ILO effective November 10, 2022 due to the COVID-19 pandemic, subsequent declaration of the State of Calamity and the implementation of community quarantine throughout the National Capital Region (NCR) and its adjacent provinces, pursuant to GPPB Resolution No. 09-2020.

Eligibility and Post-Qualification requirements shall be ensured by the bidders to be valid for another ninety (90) calendar days commencing from the date of the original expiration date of the validity of bids and bid security/bid securing declaration; and Tolling the Period of the Bidding/Procurement Activity starting from the date of suspension.

Rest assured that the BBAC will notify all concerned bidders on the resumption of the procurement activities for the above-listed project in compliance with GPPB Resolution No. 09-2020.
