WHEREAS, the CF-Olongapo BBAC has been tasked to manage the procurement requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, on September 19, 2022, Human Resource Section submitted their Procurement Processing Request (PPR) to Procurement Section for the Supply, Delivery and Installation of Attendance Data Monitoring Equipment;

WHEREAS, in a Pre-Procurement Conference held on October 10, 2022, the BBAC CF-Olongapo and the end-user reviewed and evaluated all the documents presented, including the Technical Specifications/ Terms of Reference (TOR);

WHEREAS, the Invitation to Bid was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Olongapo from October 11, 2022 to October 18, 2022;

WHEREAS, during the Opening and Preliminary Examination of Sealed Quotation (Technical and Financial Components) on October 18, 2022 no bidder submitted their bid;

WHEREAS, pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184:
