

**BBAC CF-OLONGAPO RESOLUTION ON THE CANCELLATION OF THE
PROCUREMENT OF SERVICE PROVIDER FOR THE PREVENTIVE
MAINTENANCE OF THE GENERATOR SET OF CF-OLONGAPO FOR THREE (3)
YEARS UNDER ITB NO. SV22-09-017OLO**

WHEREAS, the Bingo and Marketing Sections of Casino Filipino-Olongapo has a requirement for the Procurement of Service Provider for the Preventive Maintenance of the Generator Set of CF-Olongapo for Three (3) Years under ITB No. SV22-09-017OLO with an Approved Budget for the Contract (ABC) of One Hundred Eighty Thousand Pesos (Php 180,000.00), VAT Exclusive, Zero-Rated Transaction;

WHEREAS, the Procurement Processing Request (PPR) and other pertinent documents were received by the Procurement Section on September 28, 2022;

WHEREAS, in a Pre-Procurement Conference held on September 29, 2022, the Branch Bids and Awards Committee (BBAC) CF-Olongapo discussed the details of the requirement and the schedule of procurement activities;

WHEREAS, the Request for Quotation (RFQ) was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR Casino Filipino-Olongapo from September 30, 2022 to October 7, 2022, and sent through email to prospective bidders;

WHEREAS, in a consultation meeting held on October 5, 2022, the End-User stated that upon evaluation and review, the nature of the project requires consolidation with another project that has the same component with the ongoing project;

WHEREAS, in the exercise of the Head of the Procuring Entity's (HOPE's) right to invoke the reservation clause provided under Section 41 (c) of Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR) which reads:

SEC. 41. Reservation Clause. - The Head of the Agency reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in the following situations:

c) For any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the GOP, as follows:

[x x x]

(i) if the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE;

NOW, THEREFORE, We, the Members of the BBAC CF-Olongapo, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend to the Branch Manager, as duly delegated by the Board of Directors, the cancellation of the project Procurement of Service Provider for the Preventive Maintenance of the Generator Set of CF-Olongapo for Three (3) Years¹ under ITB No. SV22-09-017OLO, pursuant to Section 41 (c) of RA 9184 and its IRR.






