**BBAC CF-DAVAO RESOLUTION RECOMMENDING APPROVAL FOR THE  
FAILURE AND CONDUCT OF RE-BIDDING**

**WHEREAS**, the Branch Bids and Awards Committee (BBAC) of Casino Filipino - Davao has been tasked to handle the procurement requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

**WHEREAS**, the Procurement Processing Request (PPR), approved Annual Procurement Plan (APP) 2022 dated January 27, 2022, and other pertinent documents were received by the Branch Bids and Awards Committee (BBAC) Secretariat on July 22, 2022;

**WHEREAS**, in a Pre-Procurement Conference held on October 16, 2022, the BBAC CF-Davao and representative from the Provisional member, I.T. Section, reviewed and evaluated all the documents presented, including the technical specifications integrated in the Bidding Documents;

**WHEREAS**, the Invitation to Bid was posted at the websites of PAGCOR and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Davao from September 22, 2022 until October 18, 2022, and also sent through email and fax to prospective bidders;

**WHEREAS**, on September 27, 2022, a Bid Bulletin No. 1 was issued to reflect the changes in the procurement schedules, which was also posted at the websites of PAGCOR and PhilGEPS, as well as in a conspicuous Bulletin Board, within the premises of CF-Davao;

**WHEREAS**, on the scheduled Pre-Bid Conference held on October 4, 2022 no bidder came to attend the meeting;

**WHEREAS**, on October 10, 2022, a Bid Bulletin No. 2 was issued to reflect minor changes identified in the Technical Specifications for the project, which was posted at the websites of PAGCOR and PhilGEPS, as well as in a conspicuous Bulletin Board, within the premises of CF-Davao;

**WHEREAS**, on the deadline for the Submission, Receipt, Opening and Preliminary Examination of Bids on October 18, 2022 no bidder submitted their bids during the scheduled time of submission;

**WHEREAS**, the BBAC of CF- Davao declared a Failure of Bidding in accordance with Section 35.1.a of the IRR of R.A. 9184, which states that:

*"Section 35. Failure of Bidding"*

*35.1. The BAC shall declare the bidding a failure when:*

*a) No bids are received;*

Equipment with re-advertisement and/or re-posting, pursuant to Section 35.3 of the IRR of RA 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates.
