UNDER ITB NO. SV22-08-007DAV**

**WHEREAS**, the Branch Bids and Awards Committee (BBAC) has been tasked to handle the procurement of the requirements of Casino Filipino Davao with the project details presented above;

**WHEREAS**, the RFQ was posted at the websites of PAGCOR and the Philippine Government Electronic Procurement System and in a conspicuous place within the premises of Casino Filipino-Davao from August 26, 2022 to September 5, 2022, and transmitted to prospective bidders;

**WHEREAS**, the Procurement Section, acting as the BBAC Secretariat, sent the RFQs to, five (5) prospective bidders;

**WHEREAS**, on the deadline for the Opening, Submission and Receipt of Quotations held on September 5, 2022, no bidder submitted their bids for lots 2 and 3, hence, the BBAC of CF-Davao declared a failure of bidding for Lots 2 & 3, in accordance with Section 34.1.a of the IRR of R.A. 9164, which states that:

*"Section 35. Failure of Bidding"*

*35.1. The BAC shall declare the bidding a failure when:*

*a) No bids are received;*
