In cases of recently expired Mayor's/Business Permits, it shall be accepted together with the official receipt as proof that the bidder has applied for the renewal within the period prescribed by the concerned local government unit, provided that the renewed permit shall be submitted as a post-qualification requirement before issuance of the Notice of Award. All blank spaces shall be filled in with the correct and accurate information as required.
- 2 Quotations submitted exceeding the Approved Budget for the Contract (ABC) shall be rejected.
- 3 The prices quoted are to be paid in Philippine Currency.
- 4 All prices quoted are **INCLUSIVE** of all applicable duties, government permits, fees, and other charges relative to the acquisition and delivery of items to PAGCOR, but **VAT Exclusive, Zero-Rated Transaction**.
- 5 For the purpose of standardization of quotations, this RFQ Form will prevail over all kinds and forms of quotation. In case of price discrepancy over the amounts in words and-in figures, the amount in words will prevail.
- 6 Award of contract shall be made to the single calculated offer/quotation which complies with the minimum technical specifications/scope of work and other terms and conditions stated herein.
- 7 Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
- 8 The supplier agrees to pay liquidated damages in the amount of one-tenth of one percent (1/10 of 1%) of the total costs of the unperformed portion of the contract

price for each day of delay, including non-working days (i.e. Saturday and Sunday), legal holidays or special non-working holidays. PAGCOR shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
