BBAC CF-DAVAO RESOLUTION RECOMMENDING APPROVAL FOR THE FAILURE OF NEGOTIATED PROCUREMENT (TWO-FAILED BIDDINGS) AND RE-CONDUCT THEREOF

WHEREAS, the Casino Filipino - Davao Branch Bids and Awards Committee (BBAC) has been tasked to handle the procurement of the requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) Casino Filipino – Davao branch with the project details presented above;

WHEREAS, the following public biddings were declared a “Failure of Bidding” by the Branch Bids and Awards Committee (BBAC), CF–Davao due to the following reasons:

WHEREAS, on July 28, 2022, the Branch Manager 1, as duly delegated by the Board of Directors, approved the failure of Re-bidding and the conduct of Negotiated Procurement (Two Failed Biddings) for Lot 2 (Supply and Delivery of Network Switch and Connectors) under ITB No. FB22-08-004DAV;

WHEREAS, on the deadline of Submission of Best Offer held on August 22, 2022, one (1) bidder, Infoworx Inc. posted the bidding fee and submitted their quotation;

WHEREAS, after the Opening and Preliminary Examination of Quotations, the following were the results:

WHEREAS, the Branch Bids and Awards Committee (BBAC) CF-Davao declared a failure of bidding in accordance with Section 35.1.b of the IRR of R.A. 9184, which states:

"Section 35. Failure of Bidding"

35.1. The BAC shall declare the bidding a failure when:

b) All prospective bidders were declared ineligible;"

NOW, THEREFORE, We, the Members of the Branch Bids and Awards Committee (BBAC) CF- Davao, hereby **RESOLVE** as it is hereby **RESOLVED**, to recommend the following resolutions:

1. Declaration of a Failure of Negotiated Procurement (Two Failed Bidding) for the Supply and Delivery of Network Switch and Connectors under ITB No. FB22-08-004DAV, pursuant to Section 35.1 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184; and
2. Re-Conduct of Negotiated Procurement (Two-Failed Biddings) pursuant to Section 35.5 of the IRR of R.A. 9184 which states that: "Should there occur a second failure of bidding, the procuring entity may resort to negotiated procurement, as provided for in Section 53.1 [Negotiated Procurement (Two Failed Biddings)] of the IRR.
