BBAC CF-GRAND REGAL RESOLUTION RECOMMENDING APPROVAL FOR THE FAILURE OF BIDDING AND THE CONDUCT OF NEGOTIATED PROCUREMENT (TWO-FAILED BIDDINGS)

WHEREAS, the Casino Filipino – Grand Regal Branch Bids and Awards Committee (BBAC) has been tasked to handle the procurement of the requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the project was started under ITB No. CB23-00-004DAV and during its first conduct of competitive bidding, during the Submission and Opening of Bids on December 29, 2023, the BBAC declared a failure of bidding pursuant to Section 35.1.a of the IRR of R.A. 9184, wherein “no bids are received.”

WHEREAS, on February 1, 2023, the Branch Manager 1, as duly delegated by the Board of Directors, approved the failure and conduct of re-bidding;

WHEREAS, CF-Grand Regal was not able to commence with the procurement within the prescribed fifteen (15) calendar day period reckoned from the declaration of the failure of bidding, in accordance with the GPPB Circular 05–2016, pending the approval of the Annual Procurement Plan (APP) 2023 of the branch;

WHEREAS, on May 4, 2023, the Board of Directors approved the request of CF-Grand Regal to proceed with the conduct of re-bidding for the Supply and Delivery of Food and Beverages (F&B) for Various Branch Marketing Themed Events;

WHEREAS, on June 14, 2023, the Branch Procurement Section (BPS), performing the functions of the BBAC Secretariat, received the Procurement Processing Request (PPR), approved Annual Procurement Plan (APP) for CY 2023, Technical Specifications and other pertinent documents pertaining to the project;

WHEREAS, in a Pre-Procurement Conference held on July 14, 2023, BBAC together with the representative of the end-user, Marketing Section, reviewed and evaluated all the documents presented and technical specifications from the previous bidding;

WHEREAS, the Invitation to Bid (ITB) was posted at the Philippine Government Electronic Procurement System (PhilGEPS) and PAGCOR websites, and in a conspicuous place within the premises of Casino Filipino-Grand Regal from July 21, 2023 to August 15, 2023;

WHEREAS, copies of the ITB were also sent to various prospective bidders through electronic mail;

WHEREAS, on August 1, 2023, during the Pre-Bid Conference, one (1) bidder attended the forum, namely, Dynasty Management and Development Corp. / Grand Regal Hotel;

WHEREAS, after the Opening and Preliminary Examination of Bids held on August 15, 2023, no bidder submitted their bids and the BBAC CF-Grand Regal declared a "Failure of Bidding" in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184, which states:

"Section 35. Failure of Bidding"

35.1. The BAC shall declare the bidding a failure when:

a) No bids are received; and"






NOW, THEREFORE, We, the Members of the Branch Bids and Awards Committee (BBAC) CF-Grand Regal, hereby **RESOLVE** as it is hereby **RESOLVED**, to recommend the following resolutions for the information or further instruction, if any, of the Branch Manager, as duly delegated by the Board of Directors:

1. Declaration of a "Failure of Bidding" for Supply and Delivery of Food and Beverages (F&B) for Various Branch and Marketing Themed Events under ITB No. CB23-00-004DAVa-07, pursuant to Section 35.1 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184; and
2. Resort to Negotiated Procurement (Two-Failed Biddings) for the Supply and Delivery of Food and Beverages (F&B) for Various Branch and Marketing Themed Events with re-posting as provided for in Section 54.2 and Annex H (Consolidated Guidelines for Alternative Methods of Procurement) of the IRR of R.A. 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates and pursuant to Section 35.5 of the IRR of R.A. 9184 since there occurred two failed biddings; and

3. To recommend for approval for the revision/updating of the 2023 Annual Procurement Plan (APP) to reflect the change in the Mode of Procurement from Competitive/Public Bidding to Negotiated Procurement (Two-Failed Biddings).
