Glossary of Acronyms, Terms, and Abbreviations

ABC –Approved Budget for the Contract.

BAC – Bids and Awards Committee.

Bid – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

Bidder – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

Bidding Documents – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

BIR – Bureau of Internal Revenue.

BSP – BangkoSentral ng Pilipinas.

Consulting Services – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

CDA - Cooperative Development Authority.

Contract – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

CIF – Cost Insurance and Freight.

CIP – Carriage and Insurance Paid.

CPI – Consumer Price Index.

DDP – Refers to the quoted price of the Goods, which means “delivered duty paid.”

DTI – Department of Trade and Industry.

EXW – Ex works.

FCA – “Free Carrier” shipping point.

FOB – “Free on Board” shipping point.

Foreign-funded Procurement or Foreign-Assisted Project–Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

Framework Agreement – Refers to a written agreement between a procuring entity and a supplier or service provider that identifies the terms and conditions, under which specific purchases, otherwise known as “Call-Offs,” are made for the duration of the agreement. It is in the nature of an option contract between the procuring entity and the bidder(s) granting the procuring entity the option to either place an order for any of the goods or services identified in the Framework Agreement List or not buy at all, within a minimum period of one (1) year to a maximum period of three (3) years. (GPPB Resolution No. 27-2019)

GFI – Government Financial Institution.

GOCC –Government-owned and/or –controlled corporation.

Goods – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term “related” or “analogous services” shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

GOP – Government of the Philippines.

GPPB – Government Procurement Policy Board.

INCOTERMS – International Commercial Terms.

Infrastructure Projects – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports,

seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

LGUs – Local Government Units.

NFCC – Net Financial Contracting Capacity.

NGA – National Government Agency.

PhilGEPS - Philippine Government Electronic Procurement System.

Procurement Project – refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

PSA – Philippine Statistics Authority.

SEC – Securities and Exchange Commission.

SLCC – Single Largest Completed Contract.

Supplier – refers to a citizen, or any corporate body or commercial company duly organized and registered under the laws where it is established, habitually established in business and engaged in the manufacture or sale of the merchandise or performance of the general services covered by his bid. (Item 3.8 of GPPB Resolution No. 13-2019, dated 23 May 2019). Supplier as used in these Bidding Documents may likewise refer to a distributor, manufacturer, contractor, or consultant.

1. The Philippine Amusement and Gaming Corporation (PAGCOR), through the PAGCOR's Corporate Budget for CY 2023 intends to apply the sum of **Two Million Nine Hundred Ninety Two Thousand Seven Hundred Forty Three Pesos and 32/100 (PhP2,992,743.32)**, VAT Exclusive, Zero-Rated Transaction, being the total ABC to payments under the contract for the Two (2) Lots Supply and Delivery of Food and Beverages for Customers for a Period of One (1) Year and the ABC and description per lot are detailed as follows:

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The PAGCOR now invites bids for the above Procurement Project. The complete schedule of deliveries is provided in the Section VI (Schedule of Requirements) of the Bidding Documents which will commence from the date of receipt by the winning supplier of the Notice to Proceed for a period of One (1) Year or until the volume or contract amount has already been depleted or consumed, whichever comes first. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from PAGCOR and interested bidders may inspect and obtain further information from the Procurement Section (PS), as the BBAC Secretariat, of PAGCOR Casino Filipino Ilocos Norte and/or inspect the Bidding Documents at the Second (2nd) Floor Viven Hotel, Barangay 1, San Nicolas, PAGCOR Casino Filipino Ilocos Norte during office hours, Monday to Friday, from 1:00 p.m. to 6:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting on **August 31, 2023 (Thursday)** until **September 25, 2023 (Monday)** from the given address and website(s) below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, based on the following schedule:

PAGCOR shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through electronic means.

Prospective bidders may also download the Bidding Documents free of charge from www.pagcor.ph and www.philgeps.gov.ph and may be allowed to submit bids provided that bidders pay the applicable fee of the Bidding Documents not later than the deadline for the submission and receipt of bids.

In effecting payment for the Bidding Documents, prospective bidders shall present either the Payment Slip, which may be secured from the PS, or a copy of this Invitation to Bid (ITB) to PAGCOR CF Ilocos Norte’s Cashier, located at the Second (2nd) Floor Viven Hotel, Barangay 1, San Nicolas, PAGCOR Casino Filipino Ilocos Norte.

6. The PAGCOR will hold a **Pre-Bid Conference on September 11, 2023 (Monday), 3:00PM at Casino Filipino Ilocos Norte (Conference Room), Second (2nd) Floor Viven Hotel, Barangay 1, San Nicolas, Ilocos Norte OR you may join through Video Conference via Zoom platform**, which shall be open to prospective bidders. 7. Bids must be duly received by the BBAC Secretariat through manual submission on or before **September 25, 2023 (Monday), 2:45PM at the Casino Filipino Ilocos Norte (Conference Room), Second (2nd) Floor Viven Hotel, Barangay 1, San Nicolas, Ilocos Norte**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be **September 25, 2023 (Monday), 3:00PM** onwards at the **Casino Filipino Ilocos Norte (Conference Room), Second (2nd) Floor Viven Hotel, Barangay 1, San Nicolas, Ilocos Norte**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Bidders shall bear all costs associated with the preparation and submission of their bids, and PAGCOR will in no case, be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

Bidders should note that PAGCOR will only accept bids from those that have paid the applicable fee for the Bidding Documents.

PAGCOR assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.

In accordance with Government Procurement Policy Board (GPPB) Circular 06-2005 - Tie-Breaking Method, the Bids and Awards Committee (BAC) shall use a non-discretionary and non-discriminatory measure based on sheer luck or chance, which is "DRAW LOTS," in the event that two (2) or more bidders have been post-qualified and determined as the bidder having the Lowest Calculated Responsive Bid (LCRB) to determine the final bidder having the LCRB, based on the following procedures:

- a) In alphabetical order, the bidders shall pick one rolled paper.
 - b) The lucky bidder who would pick the paper with a "CONGRATULATIONS" remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.
11. The PAGCOR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

Section II. Instructions to Bidders

1. Scope of Bid

The Procuring Entity, Philippine Amusement and Gaming Corporation (PAGCOR), wishes to receive Bids for the Two (2) Lots Supply and Delivery of Food and Beverages for Customers for a Period of One (1) Year under ITB No. CB23-08-005ILO with a total Approved Budget for the Contract (ABC) in the amount of **Two Million Nine Hundred Ninety Two Thousand Seven Hundred Forty Three Pesos and 32/100 (PhP2,992,743.32)**, VAT Exclusive, Zero-Rated Transaction, broken down as follows:

The Procurement Project (referred to herein as "Project") is composed of two (2) lots the details of which are described in Section VII (Technical Specifications).

2. Funding Information

- 2.1. The GOP through the source of funding as indicated below for CY 2023 in the amount of **Two Million Nine Hundred Ninety Two Thousand Seven Hundred Forty Three Pesos and 32/100 (PhP2,992,743.32)**, VAT Exclusive, Zero-Rated Transaction.
- 2.2. The source of funding is the Corporate Operating Budget – PAGCOR's Corporate Budget for CY 2023.

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

4. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

5. Eligible Bidders

- 5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- 5.2. Foreign ownership limited to those allowed under the rules may participate in this Project.
- 5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to at least twenty-five percent (25%) of the ABC of each lot participated.

The amounts of the single largest completed contract are detailed as follows:

- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

6. Origin of Goods

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under **ITB** Clause 18.

7. Subcontracts

- 7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than twenty percent (20%) of the Project.

The Procuring Entity has prescribed that Subcontracting is not allowed.

8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time at its physical address **OR** through Video Conference via Zoom platform as indicated in paragraph 6 of the **IB**.

9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

10. Documents comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 10.2. The Bidder's SLCC as indicated in **ITB** Clause 5.3 should have been completed within five (5) years prior to the deadline for the submission and receipt of bids.
- 10.3. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.

11. Documents comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 11.2. If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.

- 11.3. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.4. For Foreign-funded Procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

12. Bid Prices

- 12.1. Prices indicated on the Price Schedule shall be entered separately in the following manner:
 - a. For Goods offered from within the Procuring Entity's country:
 - i. The price of the Goods quoted EXW (ex-works, ex-factory, ex-warehouse, ex-showroom, or off-the-shelf, as applicable);
 - ii. The cost of all customs duties and sales and other taxes already paid or payable;
 - iii. The cost of transportation, insurance, and other costs incidental to delivery of the Goods to their final destination; and
 - iv. The price of other (incidental) services, if any, listed in e.
 - b. For Goods offered from abroad:
 - i. Unless otherwise stated in the **BDS**, the price of the Goods shall be quoted delivered duty paid (DDP) with the place of destination in the Philippines as specified in the **BDS**. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible country. Similarly, the Bidder may obtain insurance services from any eligible source country.
 - ii. The price of other (incidental) services, if any, as listed in **Section VII (Technical Specifications)**.

13. Bid and Payment Currencies

- 13.1. For Goods that the Bidder will supply from outside the Philippines, the bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies, shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.

13.2. Payment of the contract price shall be made in Philippine Pesos.

14. Bid Security

14.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.

14.2. The Bid and bid security shall be valid for one hundred twenty (120) calendar days from the date of the Submission, Opening and Preliminary Examination of Bids. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

15. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

16. Deadline for Submission of Bids

16.1. The Bidders shall submit on the specified date and time at its physical address as indicated in paragraph 7 of the **IB**.

17. Opening and Preliminary Examination of Bids

17.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

17.2. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

18. Domestic Preference

- 18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.

19. Detailed Evaluation and Comparison of Bids

- 19.1. The Procuring BAC shall immediately conduct a detailed evaluation of all Bids rated "*passed*," using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of RA No. 9184.
- 19.2. If the Project allows partial bids, bidders may submit a proposal on any of the lots or items, and evaluation will be undertaken on a per lot or item basis, as the case maybe. In this case, the Bid Security as required by **ITB** Clause 15 shall be submitted for each lot or item separately.
- 19.3. The descriptions of the lots or items shall be indicated in **Section VII (Technical Specifications)**, although the ABCs of these lots or items are indicated in the **BDS** for purposes of the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184. WHEREAS, PAGCOR has a requirement for the Two (2) Lots Supply and Delivery of Food and Beverages for Customers for a Period of One (1) Year under ITB No. CB23-08-005ILO, which was approved by the PAGCOR Board of Directors and included in the 2023 Annual Procurement Plan (APP);

WHEREAS, PAGCOR conducted a public bidding in accordance with the Republic Act 9184 (Government Procurement Reform Act) and its 2016 Revised Implementing Rules and Regulations on August 31, 2023 for the procurement of the Project;

WHEREAS, the SUPPLIER has submitted the lowest/single calculated responsive bid for the Project;

WHEREAS, considering that all the requisites were met, PAGCOR has accepted the bid of the **SUPPLIER**;

WHEREAS, the Branch Manager, duly delegated on February 11,2014, approved the award of the contract to the **SUPPLIER**;

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements hereunder specified, **PAGCOR** and the **SUPPLIER** hereby enter into this Purchase Contract under the following terms, conditions and specifications:

TERMS AND CONDITIONS

The rights and obligations of the parties are set forth as follows:

1. The **SUPPLIER** shall undertake the Two (2) Lots Supply and Delivery of Food and Beverages for Customers for a Period of One (1) Year with the following technical specifications:

LOT NO. 1 – SUPPLY AND DELIVERY OF FOOD AND BEVERAGE FOR CASINO GUESTS
I. GENERAL CONDITIONS:
1. The SUPPLIER must set reasonable rate for PAGCOR .
2. The SUPPLIER is duly licensed or authorized by concerned government entity to provide the goods.
3. In case of non-operations due to non-working days / Holidays/ Force Majeure. Written notice to this effect shall be given by PAGCOR to the SUPPLIER at least two (2) days prior to the cancellation of delivery. However, cancelled delivery may be adjusted, as it sees fit to the schedule of the casino operations.
4. The SUPPLIER must own, legally possess and/or have access to all the necessary kitchen and restaurant supplies, utensils, equipment necessary for the delivery of orders, such as, but not limited to: <ul style="list-style-type: none"> a) Spoon, forks, knives and chopping boards; b) Plates, glasses, cups, bowl, clean plastic wrapper and saucers; c) Various cookware; d) Various tablecloths and napkins; e) Microwave oven and food warmer; and f) Spices/condiments and clean containers for different food ingredients.
5. In the event that the SUPPLIER fails to comply with any of its undertaking, as set forth in this Contract, PAGCOR shall be released from its obligations under this Contract, without prejudice to the right of restitution, recovery and damages.
6. This Contract, and all the rights and interests herein, may not be assigned or sub-contracted to another without the consent of the party.
7. In the event that facts and circumstances arise or are discovered which render this Contract disadvantageous to the Government, as determined by PAGCOR , the parties hereto agree to immediately re-negotiate its terms and conditions, or at the option of PAGCOR , terminate the same.
8. This Contract constitutes the entire agreement between the parties pertaining to the subject matter contained in it and supersedes all prior and

contemporaneous contracts, representations, warranties and undertakings of the parties. No supplement, variation, or amendment to this Contract shall be binding unless executed in writing by all parties thereto.
9. The SUPPLIER shall present during submission of bids, their suggested menu for fifteen (15) days subjected for evaluation.
10. The SUPPLIER shall deliver the food in a daily basis per day, with one (1) extra serving for food tasting.
11. The winning SUPPLIER must submit a monthly menu, at least thirty (30) days before the start of the MENU CYCLE for Branch Food Committee approval.
12. In case the food is not sufficient within the duration of the casino operations. The SUPPLIER must accept additional orders; last call for additional orders is until 8:00 in the evening.
13. The SUPPLIER must accept any adjustment in the delivery time/date, as it sees fit to the casino operation. Notice to this effect shall be forwarded to the supplier at least one (1) day before the intended date of commencement.
14. The contract price per pax shall not be subjected to any increase or upward adjustment within the duration of Contract.
15. The SUPPLIER in lieu of their submitted Menu Cycle may opt to request for a change at any time during the duration of the Contract provided that Written Notice shall be forwarded to the Branch Food Committee for scrutiny and approval prior to implementation.
16. The SUPPLIER must submit the required Statement of Account (SOA) with complete attachments every 15 th and 30 th of the month for processing of payment.
17. The SUPPLIER will be strictly liable for customer complaints about the quality of food to be served and that PAGCOR can impose penalties for valid complaints and rejections.
18. PAGCOR has the rights to require submission of all necessary Sanitary Permits, Health Certificate, Fire Safety Inspection and regular sites inspection of the kitchen facilities.
19. The SUPPLIER shall deliver the goods with the following terms: <ul style="list-style-type: none"> a) PLACE OF DELIVERY: Casino Filipino Ilocos Norte, 2nd Floor, Viven Hotel, Barangay 1, San Francisco, San Nicolas, Ilocos Norte; b) TIME OF DELIVERY: Twelve (12) hours operation <ul style="list-style-type: none"> ❖ 4:00pm for Snacks; and ❖ 6:00pm for Meals <p>TIME OF DELIVERY: In the event that the Branch will shift to sixteen (16) hours operation.</p> <ul style="list-style-type: none"> ❖ 2:00pm for Snacks; ❖ 6:00pm for Meals; and ❖ 8:00pm for Snacks c) FREQUENCY: Daily basis except casino holidays/closure (supplier shall be notified two (2) days before the closing date); and d) COVERING PERIOD: as specified in the Notice to Proceed.

20. The SUPPLIER must issue Delivery Receipt (BIR Issued) upon delivery of the items/goods.
21. The SUPPLIER must deliver the soups in separate container for the ingredients, except as it sees fit.
22. The SUPPLIER must see to it that the food to be delivered is not spoiled or will not get spoiled within the next two (2) hours after delivery.
23. The SUPPLIER must see to it that the foods are fresh upon delivery, it shall be ascertained within one (1) hour from delivery. Otherwise, a replacement shall be made within two (2) hours from receipt of notice.
24. The SUPPLIER must provide Serving Trays.
25. The SUPPLIER must provide a microwaveable serving plates and utensils (spoon, fork & knives)
26. The SUPPLIER must see to it that the goods to be delivered are in a fresh and presentable state.
27. PAGCOR reserves the right to modify declared suggested MENU CYCLE or serving quantity as it sees fit. Notice to this effect shall be forwarded to the supplier at least one (1) day before the intended date of commencement, provided, that the price per therein shall not be subject to any increase or upward adjustment.
28. Payment shall be based on actual billing and consumption and shall not exceed the total contract price. However, the said contract shall be automatically terminated if the Budget is exhausted before the termination date.
29. The SUPPLIER shall accept Contract for a period of one (1) year upon receipt of notice, as stated in the Notice to Proceed.
II. OTHER CONDITIONS:
1. Quotations should be VAT-exclusive and as zero-rated transaction.
2. Quotations shall not exceed the approved budget of Two Million Four Hundred Ninety Three Thousand Two Hundred Thirty Seven Pesos and 00/100 (PhP2,493,237.00).
III. OTHER MANDATORY REQUIREMENTS (WAIVER OF LIABILITY):
1. The SUPPLIER has good title to the goods described in the PURCHASE CONTRACT , full authority to sell and transfer the same and that the items are sold free and clear of all liens, encumbrances, liabilities and adverse claims, of every nature and description.
2. The SUPPLIER will fully defend, protect, indemnify and hold PAGCOR harmless from any and all adverse claims that may be made by any party for the possession and/or use of the goods.
3. PAGCOR accepts no liability for the damage of the goods during transit, risk and title will be deemed to have passed to PAGCOR only upon receipt and final acceptance of goods.

6. Delivery Period: Staggered delivery within five (5) calendar days upon receipt of notice to delivery.

8. No terms or conditions of this Contract shall be deemed waived and no breach or default excused unless such waiver shall be in writing and signed by the party affected.
9. The rights or obligations under this Contract are of a personal nature and compliance thereof may not be assigned or subcontracted to another without the written consent of the other party. This Contract or any interest in it may not be assigned without the prior written consent of the other party.

10. This Contract contains all the covenants and stipulations agreed upon by the parties and shall be modified, revised or amended only upon written agreement of both parties.
11. This Contract constitutes the entire contract between the parties pertaining to the subject matter contained in it, and supersedes all prior and contemporaneous agreements, representations, warranties and understandings of the parties. No supplement, variation or amendment of this Contract shall be binding UNLESS executed in writing by the parties. No waiver of any of the provisions of this Contract shall be deemed, or shall constitute, a waiver of any other provision, whether similar or not similar, nor shall any waiver constitute a continuing waiver. No waiver shall be binding UNLESS in writing and signed by the party making the waiver.

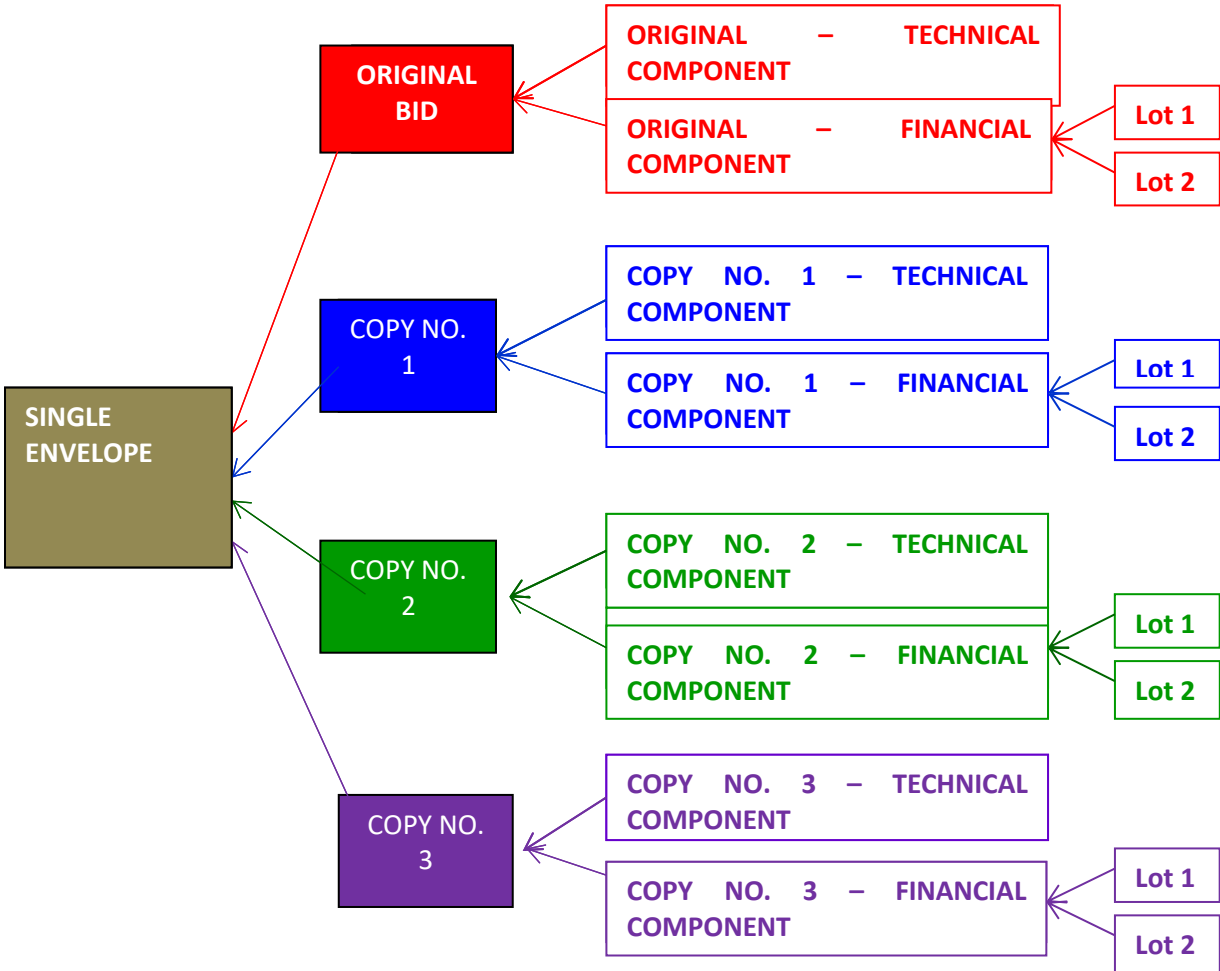
