BBAC CF-DAVAO RESOLUTION RECOMMENDING APPROVAL FOR THE FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF FOOD AND BEVERAGES (F&B) FOR VARIOUS BRANCH AND MARKETING THEMED EVENTS UNDER ITB NO. CB23-00-004DAV

WHEREAS, the Branch Bids and Awards Committee (BBAC) CF-Davao has been tasked to handle the procurement of requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the Procurement Processing Request (PPR), Indicative Annual Procurement Plan (APP) for CY 2023, Technical Specifications and other pertinent documents were received by the Procurement Section (PS), acting as the BBAC Secretariat on December 19, 2022;

WHEREAS, in a Pre-Procurement Conference held last December 27, 2022, the BBAC CF-Davao together with the representative of the end-user, Marketing Section, reviewed and evaluated all the documents presented, including the technical specifications integrated in the Bidding Documents;

WHEREAS, the Invitation to Bid (ITB) was posted at the websites of PAGCOR and the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Davao from December 29, 2022 to January 23, 2023;

WHEREAS, copies of the ITB were also sent to prospective bidders thru electronic mail;

WHEREAS, after the Opening and Preliminary Examination of Bids held on January 23, 2023, no bidder submitted their bids and the BBAC CF-Davao declared a "Failure of Bidding" in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184, which states:

"Section 35. Failure of Bidding"

35.1. *The BAC shall declare the bidding a failure when:*
