BBAC RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE QUOTATION (SCRQ) AND RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT TO TWO NOTES ENTERTAINMENT SERVICES

WHEREAS, the Branch Bids and Awards Committee (BBAC), CF-Tagaytay has been tasked to handle the procurement requirements of CF-Tagaytay with project details presented above;

WHEREAS, the Requisition Voucher (RV), Copy of the approved Annual Procurement Plan (APP) for CY 2022, Terms of Reference, Quotations and other pertinent documents were received by the Procurement Section on October 12, 2022;

WHEREAS, on the deadline for the Submission and Receipt of Quotation, **TWO NOTES ENTERTAINMENT SERVICES** submitted its quotation on time.

WHEREAS, after the Preliminary Examination of Quotation (Eligibility and Technical and Financial Component of the Proposal), **TWO NOTES ENTERTAINMENT SERVICES** got "Passed" rating:

WHEREAS, the financial offer of **TWO NOTES ENTERTAINMENT SERVICES** is within the approved budget amounting to Two Hundred Six Thousand Eight Hundred Ninety-Six Pesos and 50/100 (PhP206,896.50), VAT-Exclusive, Zero-Rated Transaction.

WHEREAS, on November 9, 2022, the end-user, Entertainment Section submitted an Evaluation Report for the offer of **TWO NOTES ENTERTAINMENT SERVICES** as the bidder having submitted the **Single Calculated Quotation (SCQ)** and stated that the proposal of the bidder is compliant with the end-user's requirement and the quotation offer for the project is within the Approved Budget for the Contract (ABC);

WHEREAS, based on the Procurement Department (PD)'s Verification Report dated November 3, 2022 the following documents submitted by **TWO NOTES ENTERTAINMENT SERVICES** were found to be authentic and valid:

- a) Business Permit for CY 2022
- b) PhilGEPS Registration Certificate; and

- c) Omnibus Sworn Statement, as confirmed with the official website of the GPP is not included in the list of blacklisted suppliers.

WHEREAS, during the Deliberation Meeting held on November 15, 2022 the BBAC examined and validated the eligibility, technical and financial quotation of **TWO NOTES ENTERTAINMENT SERVICES** as presented in the evaluation report of the end-user and post-qualification report for the project and noted that all documents were "Verified" and "Evaluated";

WHEREAS, upon careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder having the **Single Calculated Quotation (SCQ)**, the quotation of **TWO NOTES ENTERTAINMENT SERVICES** was found to be responsive;

WHEREAS, based on the results of the post-qualification process and having passed all the criteria for the eligibility, technical and financial requirements, the BBAC CF-Tagaytay resolved to recommend the award of contract to **TWO NOTES ENTERTAINMENT SERVICES** having the **Single Calculated Quotation (SCQ)** for the project;


NOW, THEREFORE, We, the Members of the BBAC, hereby **RESOLVE** as it is hereby **RESOLVED** the following:


- a) To declare **TWO NOTES ENTERTAINMENT SERVICES** as the bidder having the **Single Calculated Responsive Quotation (SCRQ)** for the **Procurement of Various Entertainers for Marketing Events of CF-Tagaytay (Duo Performing Band)** under ITB No. **SS22-10-003TAG**; and
- b) To recommend for approval of the Branch Manager II, Casino Filipino - Tagaytay, as duly delegated by the Board of Directors of PAGCOR, the award of the contract to **TWO NOTES ENTERTAINMENT SERVICES** for having the **Single Calculated Responsive Quotation (SCRQ)** for the **Procurement of Various Entertainers for Marketing Events of CF-Tagaytay (Duo Performing Band)** under ITB No. **SS22-10-003TAG** with a total contract price of Two Hundred Six Thousand Eight Hundred Ninety-Six Pesos and 50/100 (PhP206,896.50), VAT Exclusive, Zero Rated Transaction.
