WHEREAS, the Branch Bids and Awards Committee (BBAC), CF-Tagaytay has been tasked to handle the procurement requirements of CF-Tagaytay with the project details presented above;

WHEREAS, the project was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government and Electronic Procurement System (PhilGEPS) and in conspicuous place within the premises of CF – Tagaytay from November 7 to December 5, 2022;


WHEREAS, copies of the bidding documents were also sent through email to prospective bidders;

WHEREAS, during the Submission, Acceptance, Opening and Preliminary Examination of Bids held last December 5, 2022, no bids were received for Lots 1, 4, 5 and 7:

NOW THEREFORE, We, the Members of the Branch Bids and Awards Committee (BBAC), hereby **RESOLVE**, as it is hereby **RESOLVED** the following:

- a) To declare failure of bidding for Lots 1, 4, 5 and 7 of the **Supply and Delivery of Various Equipment and Other PPE's under ITB No. CB22-11-009TAG**, pursuant to Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184 to wit – *"The BAC shall declare the bidding a failure when no bids are received."*; and




