**BBAC RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE QUOTATION (SCRQ) AND RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT**

**WHEREAS**, the Marketing and Entertainment Section has a requirement for the Procurement of Services of Entertainers (Infinite Band) with an Approved Budget (ABC) for the contract amounting to One Hundred Forty-Six Thousand Five Hundred Fifty-One and 80/100 Pesos (₱146,551.80), VAT-Exclusive, Zero-Rated Transaction;

**WHEREAS**, on March 23, 2023, the Board of Directors approved the Annual Procurement Plan (APP) for CY 2023, which includes the requirement of the end-user, Marketing and Entertainment Section (MES) for the Procurement of Services of Entertainers, with Negotiated Procurement Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services (SSAEM) as the mode of procurement, upon the favorable recommendation of the Branch Bids and Awards Committee (BBAC);

**WHEREAS**, the use of Negotiated Procurement, 53.6 SSAEM is based on the following grounds:

1. The requirement is in accordance with the conditions provided in Section 53.6 (a) and Annex H of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, which provides that;

“Negotiated Procurement is a method of Procurement of Goods, Infrastructure Projects and Consulting Services, whereby the Procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in any of the following cases:

**Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services.** Where Goods, Infrastructure Projects and Consulting Services can be contracted to a particular supplier, contractor, or consultant as determined by the HOPE, for any of the following reasons:

1. The requirement is for:

- a. Work of art, commissioned work or services of an artist for specific artistic skills (e.g. singer, performer, poet, writer, painter, sculptor, etc.)

2. As per the end-user's justification dated March 30, 2023, the talented group has captivated PAGCOR's target audience and are qualified not only in performance, but also in terms of availability, rates, and documentary requirements; and
3. As per end-user's justification dated March 30, 2023, the Casino Filipino-Olongapo has clamor for the performance of the above-mentioned celebrity/performing artists, wherein their performances will bring more vibe and as a form of marketing strategy to acquire, retain and reactive potential customers of the branch.

**WHEREAS**, in a Pre-Procurement Conference held on April 19, 2023, the BBAC agreed to proceed with the finalization of the request for Quotation (RFQ) and Pro-forma Service Contract based on the presentation and review of the technical specifications and justifications submitted by the end-user, MES;

**WHEREAS**, on April 20, 2023, the Procurement Section (PS) sent the RFQ to Eurika Events Management Services, with the assistance of the end-user, MES;

**WHEREAS**, on April 26, 2023, Eurika Events Management Services submitted their accomplished RFQ with a financial offer in the total amount of One Hundred Forty-Six Thousand Five Hundred Fifty-One and 80/100 Pesos (₱146,551.80), VAT-Exclusive, Zero-Rated Transaction ;

**WHEREAS**, Eurika Events Management Services also submitted the following eligibility documents, which were verified, validated and found to be valid by the Procurement Planning Monitoring & Services Department (PPMSD), Procurement Section (PS), and the End-user:

1. DTI Registration Certificate;
2. Business Permit for CY 2023 issued by the local government of Olongapo City;
3. Group Profile;
4. Notarized Special Power of Attorney (SPA);
5. Philippine Government Electronic Procurement System (PhilGEPS) Registration Number 393913; and
6. Omnibus Sworn Statement.

**WHEREAS**, in a memorandum dated April 28, 2023, the Marketing and Entertainment Section in their evaluation report stated that they have reviewed the technical and financial components of the quotations submitted by Eurika Events Management Services and have determined to be complete and arithmetically accurate, acceptable and compliant with Marketing and Entertainment Section's requirement;



**WHEREAS**, the BBAC also noted that all the eligibility, technical and financial documents submitted have been verified and evaluated by the PPMSD, PS, and end-user, MES, in which the results were found to be valid, in order, acceptable and compliant with the requirements;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility documents submitted and verified by the PPMSD, PS and the favorable findings of the end-user on the technical and financial components of the quotation submitted by the bidder, the BBAC resolved to recommend the award of the contract of the Procurement of Services of Entertainers (Infinite Band) under ITB No. SS23-04-005OLO with a total contract price in the amount of One Hundred Forty-Six Thousand Five Hundred Fifty-One and 80/100 Pesos (₱146,551.80), VAT-Exclusive, Zero-Rated Transaction;

**NOW, THEREFORE**, We, the Members of the Branch Bids and Awards Committee (BBAC) of CF- Olongapo, hereby **RESOLVE** as it is hereby **RESOLVED**:


1. To declare Eurika Events Management Services as the bidder for having the Single Calculated Responsive Quotation (SCRQ) for the **Procurement of Services of Entertainers (Infinite Band) under ITB No. SS23-04-005OLO**; and

To recommend for approval by the Branch Manager to the award of contract to Eurika Events Management Services for having submitted the Single Calculated Responsive Quotation (SCRQ) for the **Procurement of Service Provider for Nightly Entertainers (Infinite Band) under ITB No. SS23-04-005OLO** with a contract price in the total amount of One Hundred Forty-Six Thousand Five Hundred Fifty-One and 80/100 Pesos (₱146,551.80), VAT-Exclusive, Zero-Rated Transaction.
