**BBAC RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT TO PESTICON ENTERPRISES INC.**

**WHEREAS**, the Branch Bids and Awards Committee (BBAC), CF Tagaytay has been tasked to handle the procurement requirements of CF Tagaytay with project details presented above;

**WHEREAS**, the Requisition Voucher (RV), Copy of the approved Annual Procurement Plan (APP) for CY 2023, Terms of Reference, Quotations and other pertinent documents were received by the Procurement Section on May 16, 2023;

**WHEREAS**, the Request for Quotation (RFQ) was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Tagaytay from May 23, 2023 to May 29, 2023, and transmitted to prospective bidders;

**WHEREAS**, on May 29, 2023, the deadline for the Submission and Receipt of Quotations, the following bidders submitted their quotations on time, namely:

1. NOVEE PEST CONTROL; and
2. PESTICON ENTERPRISES INC.

**WHEREAS**, on the same day the sealed quotations were opened and examined by the BBAC Secretariat in the presence of the representatives from end-user Facilities Management Section (FMS) and Security Division.

**WHEREAS**, after the Opening and Preliminary Examination of Quotations the results were as follows:

**WHEREAS**, after the conduct of the detailed bid evaluation on June 7, 2023, the BBAC of CF Tagaytay declared the quotation of PESTICON ENTERPRISES INC. as the bidder having the Lowest Calculated Quotation (LCQ) in the amount of Eight Hundred Four Thousand One Hundred Sixty-Eight Pesos (PhP804,168.00), VAT Exclusive, Zero Rated Transaction.

**WHEREAS**, the Procurement Section acting as BBAC Secretariat was instructed to issue a Notification to PESTICON ENTERPRISES INC., declaring its quotation as the Lowest Calculated Quotation.

**WHEREAS**, on **June 8, 2023**, the end-user, Facilities Management Section submitted an Evaluation Report for the offer of **PESTICON ENTERPRISES INC.** as the bidder having the **Lowest Calculated Quotation (LCQ)** and stated that the proposal of the bidder is compliant with the end-user's requirement and quotation offer for the project is within the Approved Budget for the Contract (ABC);

**WHEREAS**, on June 14 & 21 and July 20, 2023 dated of the Procurement Group (PG)'s Verification Report the following documents submitted by **PESTICON ENTERPRISES INC.** were found to be authentic and valid:

- a) SEC Registration No. CS200507542;
- b) Business Permit;
- c) PhilGEPS Registration Certificate No. **201206550171776371481**;
- d) Annual Income Tax Return 2022 with Reference No. **462300053219127**;
- e) Omnibus Sworn Statement as confirmed with the official website of the GPBB, **PESTICON ENTERPRISES INC.** is not included in the list of blacklisted suppliers.

**WHEREAS**, during the Deliberation Meeting held on July 24, 2023 the BBAC examined and validated the eligibility, technical and financial quotation of **PESTICON ENTERPRISES INC.** as presented in the evaluation report of the end-user and post-qualification report for the project and noted that all documents were "Verified" and "Evaluated";

**WHEREAS**, upon careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder having the **Lowest Calculated Quotation (LCQ)**, the quotation of **PESTICON ENTERPRISES INC.** was found to be responsive;

**WHEREAS**, based on the results of the post-qualification process and having passed all the criteria for the eligibility, technical and financial requirements, the BBAC of CF Tagaytay resolved to recommend the award of contract to **PESTICON ENTERPRISES INC.** for having the **Lowest Calculated Quotation (LCQ)** for the project;


**NOW, THEREFORE**, We, the Members of the BBAC, hereby **RESOLVE** as it is hereby **RESOLVED** the following:


- a) To declare **PESTICON ENTERPRISES INC.** as the bidder having the **Lowest Calculated Responsive Quotation (LCRQ)** for the **Procurement of Services for Pest Control for Three (3) Years** under ITB No. **SV23-05-005TAG** and;
- b) To recommend for approval of the Branch Manager II, Casino Filipino Tagaytay, as duly delegated by the Board of Directors of PAGCOR, the award of the contract to **PESTICON ENTERPRISES INC.** for the **Procurement of Services for Pest Control for Three (3) Years** under ITB No. **SV23-05-005TAG** with a total contract price of **Eight Hundred Four Thousand One Hundred Sixty-Eight Pesos (PhP804,168.00)**, VAT Exclusive, Zero Rated Transaction.


