Dear Mr. Betita:

We would like to inform you of the PAGCOR's decision/approval on the cancellation of the award of contract, based on the recommendation of the end-user, Table Games Department (TGD), considering that the processing of the final requisites for the contract was not completed.

The Bids and Awards Committee (BAC) 2 also noted that the project was approved by the previous PAGCOR Board of Directors, as the Head of the Procuring Entity (HoPE) at the time of release of the Notice of Award. Meanwhile, the condition for the procurement of Highly Technical Consultants, provided under Section 53.7 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, states *that the term of the individual consultants shall, at the most, be on a six-month basis, renewable at the option of the appointing HoPE, but in no case shall exceed the term of the latter.*


Thus, the Notice of Award issued in your favor is hereby cancelled/revoked.



