BBAC CF-GRAND REGAL RESOLUTION RECOMMENDING APPROVAL FOR THE FAILURE AND CONDUCT OF RE-BIDDING FOR LOT 2 OF THE SUPPLY AND DELIVERY OF CONSTRUCTION AND MAINTENANCE SUPPLIES AND MATERIALS UNDER ITB NO. CB23-06-006DAV

WHEREAS, the Casino Filipino – Grand Regal Branch Bids and Awards Committee (BBAC) has been tasked to handle the procurement of the requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) Casino Filipino – Grand Regal branch with the project details presented above;

WHEREAS, the Procurement Processing Request (PPR), and other pertinent documents were received by the Procurement Section (PS), acting as the BBAC Secretariat, on May 10, 2023;

WHEREAS, in a Pre-Procurement Conference held on June 1, 2023, the BBAC CF-Grand Regal and Facilities Management & Engineering Section (FMES), reviewed and evaluated all the documents presented, including the Technical Specifications/ Terms of Reference (TOR) integrated in the bidding documents and agreed to proceed with the finalization and posting of the project in the PAGCOR and PhilGEPS websites;

WHEREAS, the Invitation to Bid was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Grand Regal from June 7 to 27, 2023 and also sent through email and fax to prospective bidders;

WHEREAS, during the Pre-bid Conference on June 15, 2023, the Committee discussed the salient procedures for the conduct of public bidding and the contents of the bidding documents to four prospective (4) bidders who attended the conference, namely:

- 1) Tomas Electrical Supply Corp.
- 2) TPV Trading
- 3) Uptown Industrial Sales, Inc.
- 4) Goldman's Supply Corp.

WHEREAS, on June 20, 2023, a Bid Bulletin No. 1 was issued to reflect minor changes identified in the Technical Specifications for the project, which was posted at the websites of PAGCOR and PhilGEPS, as well as in a conspicuous Bulletin Board, within the premises of CF-Grand Regal;

WHEREAS, four (4) bidders, bought the bidding documents, namely:

- 1) Tomas Electrical Supply Corp. (Lot 1)
- 2) TPV Trading (Lot 3)
- 3) Uptown Industrial Sales, Inc. (Lot 1)
- 4) Goldman's Supply Corp. (Lot 1)

WHEREAS, on June 26, 2023, a Bid Bulletin No. 2 was issued to reflect the changes in the following procurement schedules:

1. Submission and Receipt of Bids from June 27, 2023 to July 3, 2023.

WHEREAS, the Bid Bulletin No. 2 was posted on June 26, 2023 at the website of PAGCOR and PhilGEPS, as well as in a conspicuous Bulletin Board, within the premises of CF-Grand Regal;

WHEREAS, on July 3, 2023, the Branch Bids and Awards Committee (BBAC) CF-Grand Regal convened for the Submission, Receipt, Opening and Preliminary Examination of the Bid Envelopes of the four (4) bidders who submitted their bids, namely:

- 1) Tomas Electrical Supply Corp. (Lot 1)
- 2) TPV Trading (Lot 3)

- 3) Uptown Industrial Sales, Inc. (Lot 1)
- 4) Goldman's Supply Corp. (Lot 1)

WHEREAS, after the Opening and Preliminary Examination of the contents of the First (1st) Bid Envelopes (Eligibility Documents and Technical Component), the results were as follows:

TPV Trading	Qualified for the Opening and Preliminary Examination of the Second (2 nd) Bid Envelope (Financial Component).

Goldman's Supply Corporation	The Bidder failed to submit the Omnibus Sworn Statement using the appropriate form.

WHEREAS, after the Opening of the Second (2nd) Bid Envelopes, the results were as follows:

No. 9184; and
2. Re-conduct of bidding for **Lot 2 (Supply and Delivery of Various Hardware Supplies)** of the Supply and Delivery of Construction and Maintenance Supplies and Materials under ITB No. CB23-06-006DAV with re-advertisement and/or re-posting, pursuant to Section 35.3 of the IRR of RA 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates.
