**RESOLUTION RECOMMENDING THE APPROVAL OF THE CANCELLATION OF
THE RECONDUCT OF COMPETITIVE BIDDING FOR LOT 6**

WHEREAS, the Bids and Awards Committee (BAC) 3 has been tasked to handle the procurement of the Philippine Amusement and Gaming Corporation (PAGCOR), with the project details presented above;

WHEREAS, the Procurement Processing Request (PPR), Terms of Reference (TOR) and other pertinent documents for the project were received by the Procurement Processing Department (PPD), performing the functions of the BAC Secretariat, on January 23, 2023;

WHEREAS, the Lot 6 of the aforementioned project was previously procured through Competitive Bidding under ITB No. CB23-03-016COR but resulted to a failure pursuant to Section 35.1(b) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, since all bidders were declared ineligible;

WHEREAS, the end-user, LMD, during the Deliberation Meeting held on May 10, 2023, informed the BAC 3 of their intention to proceed with the rebidding for Lot 6;

WHEREAS, the Special Assistant to the President and Chief Operating Officer, duly delegated by the Board of Directors as the Head of the Procuring Entity (HoPE) of PAGCOR, approved on June 1, 2023 the Failure of Competitive Bidding and the reconduct thereof for Lots 2, 3, 5, 6 and 7;

WHEREAS, the end-user, LMD, through its memorandum dated June 5, 2023, requested the cancellation of the rebidding for Lot 6 due to the upcoming delivery from the previous year's project;

WHEREAS, the BAC 3, during the Pre-Procurement Conference held on June 7, 2023, discussed the rebidding for Lots 2, 3, 5 and 7 and resolved to recommend the cancellation of the rebidding/reconduct of Competitive Bidding for Lot 6, based on the request of the end-user, LMD;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee (BAC) 3, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the cancellation of the reconduct of Competitive Bidding for **Lot 6 of the Supply and Delivery of Various Beverages and Food Supplies** under ITB No. CB23-03-016COR, pursuant to Section 35.6(b) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, since the project is no longer necessary as determined by the end-user unit, LMD.
