**RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE QUOTATION (SCRQ) AND RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT TO BERKMAN SYSTEMS, INC. FOR LOT 2 OF THE PREVENTIVE MAINTENANCE SERVICES OF GENERATOR SETS AND EMISSION TESTING FOR TWO (2) GENERATOR SETS UNDER ITB NO. SV23-05-002DAV**

**WHEREAS**, the Branch Bids and Awards Committee (BBAC) CF-Grand Regal has been tasked to handle the procurement of the requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

**WHEREAS**, the Request for Quotation (RFQ) was posted at the websites of PAGCOR and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR Casino Filipino-Grand Regal on May 12, 2023 to May 22, 2023 and transmitted to prospective Bidders;

**WHEREAS**, the Procurement Section, acting as the BBAC Secretariat, also sent the RFQ's to four (4) prospective bidders.

**WHEREAS**, on the deadline for the Submission and Receipt of Quotations held on May 22, 2023, three (3) bidders, submitted their quotation for the said project namely;

1. Gendiesel Philippines, Inc. (Lot 1);
2. Philippine Diesel Calibration Cooperative (Lot 1); and
3. Berkman Systems, Inc. (Lot 2).

**WHEREAS**, on the same date, the quotations of the three (3) bidders were opened and examined by the BBAC Secretariat in the presence of the representatives from the Security Division and the end-user, Facilities Management and Engineering Section;

**WHEREAS**, After the Opening and Preliminary Examination of the submitted Sealed Quotation, results were as follows:

**WHEREAS**, the following eligibility documents of Berkman Systems, Inc. were verified by the Procurement Section and were found to be valid, as follows:

1. Business Permit 2023 No. B-84693-3, valid until December 31, 2023.
2. PhilGEPS Registration No. 200707327871540356881 under Platinum Category, valid until March 27, 2024;
3. Notarized Omnibus Sworn Statement; and
4. Notarized Secretary's certificate.

**WHEREAS**, based on the end-user's evaluation report dated May 23, 2023, the technical and financial components submitted by Berkman Systems, Inc., were found to be compliant and in order, as follows:

- 1) Request for Quotation, and
- 2) Financial Quotation.

**WHEREAS**, based on PD-PPM & SMU's verification report dated June 8, 2023, the SEC Certificate No. A200000174 submitted by Berkman Systems, Inc. was certified as valid thru secexpress.ph/;

**WHEREAS**, in a Final Deliberation Meeting held on June 9, 2023, the BBAC Secretariat presented to the BBAC CF-Grand Regal the Summary of the post-qualification report on the eligibility documents, technical and financial components of Berkman Systems, Inc. for Lot 2;

**WHEREAS**, BBAC CF-Grand Regal noted the following:

1. The technical and financial components of the quotation submitted have been verified and evaluated by the end-user as compliant, as per report dated May 23, 2023;
2. The eligibility documents submitted were verified and certified as valid by the PS and PD, as per report dated June 8, 2023;
3. Notarized Omnibus Sworn Statement and Secretary's Certificate were verified by PS to be in the correct format;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility documents submitted and verified by PS and PD, and the favorable findings of the end-user of the technical and financial components of the quotation submitted by the bidder having the Single Calculated Quotation (SCQ), Berkman Systems, Inc., their offer was found to be responsive;

**NOW, THEREFORE**, we, the Members of the Branch Bids and Awards Committee (BBAC), hereby **RESOLVE** as it is hereby **RESOLVED**:


- 1) To declare **Berkman Systems, Inc.** as the bidder having the Single Calculated Responsive Quotation (SCRQ) for **Lot 2 (Emission Testing for Two (2) Generator Sets)** of the Preventive Maintenance Services of Generator Sets and Emission Testing for Two (2) Generator Sets under ITB No. SV23-05-002DAV, and
- 2) To recommend for approval by the Branch Manager of CF-Grand Regal, as duly delegated by the Board of Directors, the award of contract to **Berkman Systems, Inc.** for **Lot 2 (Emission Testing for Two (2) Generator Sets)** of the Preventive Maintenance Services of Generator Sets and Emission Testing for Two (2) Generator Sets under ITB No. SV23-05-002DAV with a total contract price of **Eighty Thousand Pesos (PhP 80,000.00)**, VAT Exclusive, Zero-Rated Transaction.
