BBAC RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE QUOTATION (SCRQ) AND RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT TO GOT2GO VEN2RES, INC.

WHEREAS, on May 4, 2022, the Board of Directors approved the Annual Procurement Plan (APP) for CY 2022 of CF-Tagaytay, which includes the requirement of the end-user, Entertainment Section, for the Procurement of Various Entertainers for Marketing Events of CF-Tagaytay (All Female Dancers) through (SSAEM) as mode of procurement;

WHEREAS, the mode of procurement for the project is Negotiated Procurement, 53.6 Scientific Scholarly or Artistic Work, Exclusive Technology and Media Services (SSAEM) based on the following grounds;

1. The requirement is in accordance with conditions provided in Section 53.6 (a) and Annex H of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, which provides that;

"Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting Services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in any of the following cases:

Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services. Where Goods, Infrastructure Projects and Consulting Services can be contracted to a particular supplier, contractor, or consultant as determined by the HOPE, for any of the following reasons:

a. *Work of art; commissioned work or services of an artist for specific artistic skills (e.g. singer, performer, poet, writer, painter, sculptor, etc.)*

WHEREAS, on October 12, 2022, the end-user, Entertainment Section submitted its Procurement Processing Request (PPR) for the project with the following required documents:

1. Portion of Approved 2022 APP reflecting the project;
2. Requisition Voucher;
3. Terms of Reference;
4. Quotations;
5. Justification for the Procurement of Go Girls as Nightly Entertainer (All Female Dancers); and
6. Draft Service Contract

WHEREAS, during the Pre-Procurement Conference held last October 12, 2022, the BBAC reviewed the justification for the Procurement of Various Entertainers for Marketing Events of CF-Tagaytay (All Female Dancers);

WHEREAS, the committee agreed to finalize the Request for Quotation for the project to be issued to prospective service provider;

WHEREAS, on October 13, 2022, Procurement Section (PS) sent the RFQ to Got2Go Ven2res, Inc., through electronic mail, with the assistance of the end-user, Entertainment Section;

WHEREAS, on October 20, 2022, Got2Go Ven2res, Inc. submitted its duly accomplished RFQ with a financial offer in the total amount of Four Hundred Ninety Thousand Eight Hundred Forty-Three Pesos (PhP490,843.00), VAT Exclusive, Zero-Rated Transaction;

WHEREAS, on November 9, 2022, the end-user, Entertainment Section submitted its evaluation report on the following documents submitted by Got2Go Ven2res, Inc. and found the offer acceptable and compliant with the requirements:

1. Duly accomplished Request for Quotation; and
2. Company Profile

WHEREAS, the following eligibility documents were also submitted by Got2Go Ven2res, Inc., and based on Procurement Department (PD)'s verification reports dated November 9, 2022, January 16 & 30, 2023, the following were verified as valid:

1. DTI Certificate;
2. Business Permit for CY 2022;
3. PhilGEPS Registration Certificate; and

4. 2021 Annual Income Tax Return

WHEREAS, during the Deliberation Meeting held on February 24, 2023, the BBAC examined and validated the eligibility, technical and financial offer of Got2Go Ven2res, Inc. as presented in the consolidated post-qualification report for the project and noted that all documents were "Verified" and "Evaluated";

WHEREAS, based on the results of the post-qualification process and having passed all the criteria for the eligibility, technical and financial requirements, the BBAC of CF-Tagaytay resolved to recommend the award of contract to Got2Go Ven2res, Inc., talent agent of Go Girls for having the Single Calculated Responsive Quotation (SCRQ) for the project;

NOW, THEREFORE, we the Members of the Branch Bids and Awards Committee (BBAC), hereby **RÉSOLVE** as it is hereby **RESOLVED** the following:

1. To declare **Got2Go Ven2res, Inc.**, as the bidder having the Single Calculated Responsive Quotation (SCRQ) for the Procurement of Various Entertainers for Marketing Events of CF-Tagaytay (All Female Dancers) under ITB No. SS22-10-002TAG; and
2. To recommend for approval of the Branch Manager II, Casino Filipino - Tagaytay, as duly delegated by the Board of Directors of PAGCOR, the award of the contract to **Got2Go Ven2res, Inc.**, for having submitted the SCRQ for the Procurement of Various Entertainers for Marketing Events of CF-Tagaytay (All Female Dancers) under ITB No. SS22-10-002TAG with a contract price in the total amount of Four Hundred Ninety Thousand Eight Hundred Forty-Three Pesos (PhP490,843.00), VAT Exclusive, Zero-Rated Transaction.
