PAGCOR shall finalize the schedule and confirm performances/services required one (1) week before the event

PAGCOR may cancel services/performances three (3) days before the event.

Payment Terms and Conditions:

- A. Payment to Line Producers for the artist/s performances shall be based on actual shows/billing after the end of each performance.
- B. PAGCOR shall not be under any obligation to pay the LINE PRODUCER/BOOKING AGENT the entire amount of the contract price. Moreover, the aggregate billings under the Contract shall not exceed the total Contract Price.

<p>PAGCOR shall be responsible for the following:</p> <ol style="list-style-type: none"> 1. Venue with basic technical equipment. 2. Clearance / approval of the Local Government Unit (LGU) and/or Inter-Agency Task Force (IATF) allowing the branch or satellite to conduct celebrity shows. 	
<p>LINE PRODUCERS/ CONTRACTORS/BOOKING AGENTS shall be responsible for the following:</p> <ol style="list-style-type: none"> A. The Contractor must be able to provide compatible and high quality accompaniment readily available in every performance C. The Contractor shall submit a Conforme Letter signed by the artist/s or artist's manager/booking agent stipulating therein the production budget and net amount of talent fee prior to processing of payment. <p><u>Additional Conditions:</u></p> <p>The following shall be provided by the LINE PRODUCER/BOOKING AGENT:</p> <ol style="list-style-type: none"> 1. The ARTIST/S shall perform at Casino Filipino venues (Branches & Satellites) for a show (LIVE performance at the venue), and/or engage their services (e.g. Hosting, Dealing and all other related services) during Marketing Events, Gaming Events, Slot Machine Events, Bingo Events and Corporate Events LIVE performance at the venue. <p>The ARTIST/S branch assignments and date of performances shall not be replaced by the LINE PRODUCER/BOOKING AGENT without express Written Consent from PAGCOR. However, PAGCOR may change/replace artist, branch assignment and date as deemed necessary.</p> <p>If any of the artist/s in the pool becomes unavailable/indisposed during procurement process, said artist/s shall be stricken out of the list.</p>	

If, for any cause, any or all of the ARTIST/S/ENTERTAINER/S/PERFORMER/S shall become indisposed on the day of the show, the LINE PRODUCER/BOOKING AGENT shall promptly retain the services of back-up ARTIST/S/ENTERTAINER/S/PERFORMER/S of the higher caliber, who shall perform in lieu of the original artist/s/entertainer/s/performer/s, subject to the approval of the PAGCOR.

If the Show/event is prevented, rendered impossible or unfeasible by causes which are classified as fortuitous events, health condition, life threatening, force majeure, "acts of God," acts of war, civil disturbances, riots, strike, epidemic interruption or delay of transportation, mutiny, social unrest or regulations of any public authority/bureau or any cause beyond the control of both parties herein, then parties agree to conduct further negotiations for resetting or re-scheduling of the subject project but only until December 31, 2022 or until exhaustion of the contract price whichever comes first.

The LINE PRODUCER/BOOKING AGENT shall inform PAGCOR beforehand of any cancellation or non-performance.

- If the ARTIST/S is represented by a booking agent/manager, a Special Power of Attorney (SPA) shall be executed by the Booking agent/ Manager that she/he properly authorizes the LINE PRODUCER/BOOKING AGENT to represent him/her for purposes of complying with PAGCOR's requirements.

The SPA shall be submitted for the processing of Request for Payment (RFP). Checks shall be made payable to LINE PRODUCER/BOOKING AGENT.

2. Must be gross amount and VAT Exclusive, Zero-Rated Transactions.

VALIDITY OF OFFER: Ninety (90) calendar days from the date of receipt of quotations

PAYMENT SCHEDULE: Payment to LINE PRODUCERS/ BOOKING AGENT for the artist/s performances shall be based on actual shows/billing after the end of each performance.

ADDITIONAL REQUIREMENTS:

The accomplished RFQ should be submitted on **November 24, 2022**. We encourage the submission of the following eligibility documents simultaneously with the RFQ but in no case later than ten (10) calendar days after submission of the RFQ.

1. Valid Mayor's Permit issued by the city or municipality where the principal place of business of the prospective bidder is located.

2. Philippine Government Electronic Procurement System (PhilGEPS) Registration Number or a valid PhilGEPS Registration Certificate;
3. Latest Income or Business Tax Returns filed and paid through the BIR Electronic Filing and Payment System (EFPS):

In accordance with Executive Order (E.O.) No. 398, Revenue Regulation (R.R.) No. 03-2005 and Revenue Memorandum Circular (RMC) 16 – 2005, the above-mentioned tax returns shall refer to the following:

- a) Latest Income Tax Return (ITR) shall be the ITR for the preceding year, whether calendar or fiscal, or
 - b) Latest Business Tax Returns shall refer to the Value Added Tax (VAT) or Percentage Tax filed and paid covering the previous six (6) months before the date of Submission, Receipt, and Opening & Preliminary Examination of Bids/Quotations.
4. Omnibus Sworn Statement in accordance with the attached prescribed form.

The Omnibus Sworn Statement shall be supported by an attached document showing proof of authorization, e.g., original copy of a duly notarized Secretary's Certificate (in case of corporations, partnerships or joint ventures) or a Special Power of Attorney (in case of Sole Proprietor) attesting that the signatory is the duly authorized and designated representative of the prospective bidder, and granted full power and authority to do, execute and perform any and all acts necessary and/or to represent the prospective bidder in the procurement process.

NOTES:

1. Bidders shall submit their quotations through their duly authorized representatives using this form only. This form must be completed without any alterations to their format and no substitute form shall be accepted. All blank spaces shall be filled in with the correct and accurate information as required.
2. Quotations submitted exceeding the Approved Budget for the Contract shall be rejected.
3. The prices quoted are to be paid in Philippine Currency.
4. All prices quoted are **INCLUSIVE** of all applicable duties, government permits, fees, and other charges relative to the acquisition and delivery of items to PAGCOR, but **VAT Exclusive, Zero-Rated Transaction**.
5. For the purpose of standardization of quotations, this RFQ Form will prevail over all kinds and forms of quotation. In case of price discrepancy over the amounts in words and in figures, the amount in words will prevail.

6. Award of contract shall be made to the single calculated offer which complies with the minimum technical specifications/scope of work and other terms and conditions stated herein.
7. Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
8. The Contractor shall complete and/or the Services within the prescribed in this Contract.

Should the Contractor incur delay in the performance of the Services, inclusive of duly granted time extensions if any, the Contractor shall be liable for damages for the delay and shall pay liquidated damages amounting to one-tenth of one percent (1/10 of 1%) of the cost of the delayed Services for each day of delay, including Sundays and Holidays, until such Services are finally rendered and accepted by PAGCOR. Such amount shall be deducted from any money due, or which may become due to the Contractor or collected from any securities or warranties posted by the Contractor. In case the total sum of liquidated damages reaches ten percent (10%) of the total contract price, PAGCOR may rescind or terminate the contract and impose appropriate sanctions over and above the liquidated damages to be paid by the Contractor, without prejudice to other courses of action and remedies open to it.

9. Other terms and conditions are stipulated in the attached draft Service Contract.

BIDDER'S COMMITMENT:

We hereby agree and bind ourselves to the terms and conditions herein specified, to the manner of procurement and evaluation set up by the Bids and Awards Committee (BAC), to the provisions of the attached Service Contract and to the rules and regulations of the Government and PAGCOR.

We understand that PAGCOR is not bound to accept the lowest or any bid it may receive.
