
1. As the winning bidder, you shall submit, within five (5) calendar days from receipt of the Notice of Award, the soft and printed copy of at least six (6) card back designs.
2. PAGCOR shall select and approve the designs for the first, second and third batches of deliveries from the sample card back designs that will be submitted.
3. As the winning bidder, you shall submit, within ten (10) calendar days from receipt of approval from PAGCOR of the card back designs, the twelve (12) sample decks each for the red and blue cards with the approved design for the first batch of deliveries only.
4. The Notice to Proceed shall be issued upon approval of the sample decks of cards.
5. The twelve (12) sample decks each for the red and blue cards with the approved designs for the second and third batch of deliveries shall be submitted upon receipt of advice from PAGCOR
